ARTICLE I

PURPOSE AND FUNCTIONS

A non-profit corporation organized to solicit funds from individuals, foundations, businesses and government to provide an internship program to employ university students who will work in various phases of local and municipal government, thus giving students an opportunity to contribute constructively to the Atlanta area by aiding in the improvement of all phases of urban life.

ARTICLE II

Membership in the Atlanta Urban Corps, Inc., shall be composed of all employees, interns and friends of the Atlanta Urban Corps, Inc.

ARTICLE III

BOARD OF TRUSTEES

Section 1. Trustees.

- (a) Number of Trustees. The control of this corporation shall be vested in a Board of Trustees which shall consist of leading members of the community, local college presidents and student representatives.
- (b) <u>Duties</u>. The Board of Trustees shall make appointments and decisions necessary to carry out the purpose and functions of the corporation and shall be responsible for the administration of monies held by the corporation.
- (c) <u>Meetings</u>. The Board of Trustees shall meet with three days notice given by any member of the Board of Trustees or any member of the Executive Board or any administrative officer of the corporation.
- Section 2. Term. The term of regular members of the Board of Trustees shall be for one year beginning on April 1 of each year.
- Section 3. Election. Members of the Board of Trustees shall be nominated and elected by the membership of the corporation.
- Section 4. Vacancies. Vacancies shall be filled by the Board of Trustees. Trustees so chosen shall hold office for the unexpired portion of the term of their predecessors.

ARTICLE IV

EXECUTIVE BOARD

Section 1. Members and Duties. The Board of Trustees shall elect an Executive Board consisting of not less than six or more than twelve members which shall administer those funds budgeted and appropriated by the Board of Trustees and shall further handle all administrative tasks normally handled by the Board unless otherwise directed. The Executive Board shall be chosen as follows: There shall be an equal number of students and non-student representatives, with the students being chosen from nominees designated by the College Relations Board, an organization made up of representatives of the major participating colleges. Two of the members of the Executive Board shall be the Student Director of the corporation and the Staff Director.

Section 2. Meetings. The Executive Board may meet upon one day's notice given by any member of the Board without formal notice. A majority of the Board shall be a quorum and a majority of those in attendance shall be sufficient to act.

ARTICLE V

POWERS

Section 1. Grants or Gifts. The corporation shall be empowered to receive grants and gifts, by will or in any other manner, in any form of property, in trust or otherwise, wherever situated, to carry out any of its purposes. All of such grants and gifts shall be faithfully administered in accordance with the terms on which they are made.

Section 2. <u>Use of Assets</u>. All property and income of the corporation shall be used exclusively for the purposes set out in the Charter, and no part thereof shall be used for the benefit of any person whomsoever except in a manner consistent with such purposes.

Section 3. General Powers. The corporation shall have the power to retain all grants and gifts in the original form in which they were received unless otherwise required by the terms thereof; to buy, sell, exchange or otherwise deal in stocks, bonds, securities, real estate and any other form of property at public or private sale; to invest and reinvest any of its funds or property belonging to it at any time in such securities and other property, real or personal, regardless of whether such investments are legal investments for trust funds under the laws of Georgia or any other State and to borrow money and secure the payment thereof by mortgage, pledge, deed or other instrument or lien upon all or any part of the property of the corporation. All of the foregoing powers may be exercised without order of court or other authority.

Section 4. Statutory Powers. The corporation shall be vested with all of the rights, rowers, and privileges which may be necessary or proper to achieve the purposes in the charter subject to the provisions hereof; and the corporation shall have all of the powers and privileges enumerated in #22-1827 and

22-1828 of the Georgia Code, as amended, together with such other powers and privileges as may now or hereafter be given to corporations by law.

ARTICLE VI

MEETINGS

- Section 1. Annual Meeting. The corporation may hold meetings at any time with three (3) days notice, oral or written, without any minimum requirement as to number of meetings.
- Section 2. Other Meetings. Other meetings shall be called at the discretion of the Board of Trustees, Executive Board or administrative heads.
- Section 3. Quorum. A quorum at any meeting of the corporation shall consist of a majority of those in attendance.

ARTICLE VII

LIQUIDATION OR DISSOLUTION

On liquidation or dissolution the assets of the corporation shall be dedicated to a charitable #501 c (3) organization as designated under the provisions of the Internal Revenue Code.

ARTICLE VIII

AMENDMENT TO BY-LAWS

The Board of Trustees shall have the power to amend these By-Laws by a majority vote of those in attendance at any properly-called meeting.

ARTICLE IX.

- '- OFFICERS

- Section 1. The Board of Trustees and/or the Executive Board shall have the power to designate any officers they deem necessary. All officers they might choose shall be members in good standing of the Atlanta Urban Corps.
- Section 2. The administrative authority of the corporation shall be vested in two officers to be chosen by the Executive Board with the advice and consent of the Board of Trustees. One officer shall be the Student Director who shall have general responsibilities for all student interns including their recruitment within the program. The other prime administrative officer shall be the Staff Director who will be a full-time professional in charge of all non-student aspects of the program including fiscal matters and other administrative duties not directly involved with student participation.
- Section 3. Officers shall serve for one year and be elected by the Executive Board with student officers being chosen from nominees designated by the College

Relations Board. Vacancies will be filled for unexpired terms by the Frecutive Board. As mentioned previously, those offices to be filled will be designated by the Board of Trustees.

These By-Laws were tentatively approved at the first meeting of the Trustees April 17, 1969. A Committee was appointed by the Trustees to thoroughly study these By-Laws andmake recommendations at the next Trustees meeting. The Committee consisted of Mr. Norm Shavin, Dr. Walter Bloch, and Miss Dusty Kenyon.

Dear George:

This is to acknowledge your letter of November 25, 1969, which relates to my letter of November 24 regarding certain contracts that have been entered into by the City of Atlanta Urban Corps and various agencies, commissions, educational institutions and a comment I made in my letter of November 24 regarding the holding of payments for certain funds of the Urban Corps. The next to the last paragraph of my letter contains a mis-statement I would like to correct; that is to delete the wording "for income". This paragraph should have read: "In a review of my files, I do not have filed with this office an agreement relating to the number of interns the City is to receive and the consideration the City is to pay for these interns. By a copy of this letter, I am asking the Accounts Payable Auditor not to process any payments of these funds allocated for the Urban Corps until this agreement is received."

The letter to Mr. Ken Millwood was dictated on Saturday, November 22, and signed that day by me for delivery to Mr. Millwood on November 24. Your transmittal of the agreement was stamped received by this office on Monday, November 24 which is the day I was in New York.

In your letter of November 25, you state: "Not withstanding the fact you had this contract in hand before your letter was written, your threat to cut off the Urban Corp's funds is highly improper". As I explained to you over the telephone on Tuesday, November 25, the agreement was not in my hands prior to dictating my letter of November 24, and I do not consider it improper to say that I am cutting off funds of the Urban Corps. As a matter of fact, I could make no payments to the Urban Corps under the contract until the contract was thoroughly executed and received in this office.

If your statement had reference to positions that are established by Ordinances and on the payroll of the City, I can see your concern but this was certainly not the intent of my letter of November 24.

SUBJECT: Urban Corps 1970 Budget Proposal

There seems to be some question as to the derivation of the request for \$139,693 that the Urban Corps has made of the City of Atlanta. The budget was derived on a cash income - outflow basis without assigning specific usages of income to specific sources. In deriving this budget, we used income sources represented as the following:

- (1) College Work-Study 80% of salaries of eligible students
- (2) Agencies 30% of salaries of interns they employ
- (3) City of Atlanta 50% of salaries of interns they employ
- (4) City of Atlanta Supportive Grant

This plan was suggested by Mr. Berry as a method of deriving the City's financial participation based on services rendered. The private agencies were asked to pay only 30% because of their limited financial position and in an effort to keep the Urban Corps in a non-competitive situation with the colleges and universities.

The City of Atlanta has been and is now an active sponsor of the Urban Corps concept. The summer Urban Corps program was regarded a success by both local and national figures. We requested the City of Atlanta to share a larger part of the cost of defraying administrative expenses because it is the type of community activity a City government should be involved in. Also, quite frankly, the City can afford it. The City gains benefit through community service, publicity, and student involvement from the Urban Corps program in total, not only from the students who work directly with City departments.

The request of \$139,693 can be viewed in a different light than the 50%-grant combination outlined above. The administrative costs of the 1970 program will be \$75,349. Being a City sponsored program, the City could reasonably expect to absorb this total cost. The remaining \$64,344 can then be viewed as representing the City's

matching share of interns used by City departments. This cost represents 34% of the salaries of interns assigned to the City for 1970.

In using this \$64,344 in computing cost per man year, the result is:

\$64,344 for 44.1 man years = \$1,459.02 per man year

(The 52 man years quoted by Mr. Dan Sweat in his memo of November 5, 1969, is inaccurate because it does not allow for part-time employment. Using 52 man years, the cost is \$1,237.39 per man year.)

The cost to the private agencies participating is:

93 man years for \$116,808 = \$1,256 per man year.

Accepting the afgument that the City truly benefits from all the interns in the Corps, the cost per man year would be:

137 man years-\$139,693 = \$1,042 per man year

(This figure does not include the 31 staff members who in total will contribute some 17 full man years to the operation.)

I believe these computations make the City's involvement more reasonable in compasison to that of the non-profit agencies. I feel the key point is not one of finance, but one of purpose. The Urban Corps, although it has involved financial ties, is not based on percentages of cost, cost per man year, or who pays how much. It is based entirely on service to the community and educational enrichment of the students. It would seem to me that it is worth at least \$140,000 to the City to continue such an enterprise.

SUBJECT: Urban Corps 1970 Budget Proposal

There seems to be some question as to the derivation of the request for \$139,693 that the Urban Corps has made of the City of Atlanta. The budget was derived on a cash income - outflow basis without assigning specific usages of income to specific sources. In deriving this budget, we used income sources represented as the following:

- (1) College Work-Study 80% of salaries of eligible students
- (2) Agencies 30% of salaries of interns they employ
- (3) City of Atlanta 50% of salaries of interns they employ
- (4) City of Atlanta Supportive Grant

This plan was suggested by Mr. Berry as a method of deriving the City's financial participation based on services rendered. The private agencies were asked to pay only 30% because of their limited financial position and in an effort to keep the Urban Corps in a non-competitive situation with the colleges and universities.

The City of Atlanta has been and is now an active sponsor of the Urban Corps concept. The summer Urban Corps program was regarded a success by both local and national figures. We requested the City of Atlanta to share a larger part of the cost of defraying administrative expenses because it is the type of community activity a City government should be involved in. Also, quite frankly, the City can afford it. The City gains benefit through community service, publicity, and student involvement from the Urban Corps program in total, not only from the students who work directly with City departments.

The request of \$139,693 can be viewed in a different light than the 50%-grant combination outlined above. The administrative costs of the 1970 program will be \$75,349. Being a City sponsored program, the City could reasonably expect to absorbe this total cost. The remaining \$64,344 can then be viewed as representing the City's

matching share of interns used by City departments. This cost represents 34% of the salaries of interns assigned to the City for 1970.

In using this \$64,344 in computing cost per man year, the result is:

\$64,344 for 44.1 man years = \$1,459.02 per man year

(The 52 man years quoted by Mr. Dan Sweat in his memo of November 5, 1969, is inaccurate because it does not allow for part-time employment. Using 52 man years, the cost is \$1,237.39 per man year.)

The cost to the private agencies participating is:

93 man years for \$116,808 = \$1,256 per man year.

Accepting the aggument that the City truly benefits from all the interns in the Corps, the cost per man year would be:

\33 man years-\$139,693 = \$1,042 per man year

(This figure does not include the 31 staff members who in total will contribute some 17 full man years to the operation.)

I believe these computations make the City's involvement more reasonable in compasison to that of the non-profit agencies. I feel the key point is not one of finance, but one of purpose. The Urban Corps, although it has involved financial ties, is not based on percentages of cost, cost per man year, or who pays how much. It is based entirely on service to the community and educational enrichment of the students. It would seem to me that it is worth at least \$140,000 to the City to continue such an enterprise.

(The 52 man years quoted by Mr. Dan Sweat in his memo of November 5, 1969, is inaccurate because it does not allow for part-time employment. Using 52 man years, the cost is \$1,237.39 per man year.)

The cost to the private agencies participating is:

93 man years for \$116,808 = \$1,256 per man year.

Accepting the afgument that the City truly benefits from all the interns in the Corps, the cost per man year would be:

137 man years-\$139,693 = \$1,042 per man year

(This figure does not include the 31 staff members who in total will contribute some 17 full man years to the operation.)

I believe these computations make the City's involvement more reasonable in compasison to that of the non-profit agencies. I feel the key point is not one of finance, but one of purpose. The Urban Corps, although it has involved financial ties, is not based on percentages of cost, cost per man year, or who pays how much. It is based entirely on service to the community and educational enrichment of the students. It would seem to me that it is worth at least \$140,000 to the City to continue such an enterprise.

Dear Mr. Farris:

Let me extend my appreciation to you and the members of your Committee for the opportunity to present the 1970 Budget Proposal for the Atlanta Urban Corps. Hopefully, the Proposal is detailed enough to give a concise picture of the needs of the Program next year. Because of the necessity of making a brief presentation, I fear many of the important facts about the Corps were not voiced. I believe these several points will make the amount we are requesting more reasonable from a return-on-investment viewpoint.

- (1) The Urban Corps provides an abundant manpower source that has been overlooked. The majority of the students involved are in the upper level in college or in graduate or professional school.
- (2) The jobs the students perform are all existing jobs that have been left undone due to a lack of manpower, and with the creative cooperation between the Urban Corps and City administrators, many very necessary tasks can be performed by interns.
- (3) According to the figures provided by the Mayor's Office, the interns will provide 52 man years of labor at an average cost of \$2,690.00. This cost is extremely low based on the earning power potential of a college graduate or near-graduate. Also, it does not include the 17 man years worked by the proposed staff.
- (4) The Urban Corps offers the potential of a manpower training program for the City by acquainting students with the possibilities of government employment after graduation. No one can deny that with only 125 of approximately 8,000 City employees (excluding the Board of Education and the Library) having college degrees, that the recruitment of highly qualified

people into city government has been a major problem.

These are only the quantifiable potentials of an effective Urban Corps program. The very real potentials of community benefit, educational enrichment, a counter-measure to student radicalization, and the benefit to the individual student are also deeply rooted into the Urban Corps concept.

As further clarification, let me say that the budget asks for \$75,349 to finance the administration of the Urban Corps for one year. An additional \$64,344 (making a total of \$139,693) is needed to meet the City's share of the salaries of interns working in city departments. (This cost represents 34% of these interns total stipend which is comparable to the 30% paid by non-city agencies.)

Thank you for your consideration of this summary and to the Urban Corps proposal. We welcome your Committee's evaluation of the benefits of our Program to the City, and hope you will discuss its value with interns working both in City Hall and in non-city agencies.

Dear Charles:

I am attaching a copy of the Atlanta Urban Corps Budget and Program Proposal for 1970. This proposal has been prepared by the staff of the Urban Corps.

As I understand the document, it proposes programs of 60 Interns in the Spring: 500 Interns in the Summer; and 100 Interns in the Fall. The gross program cost will be \$650,623 of which \$510,930 will be met by contractual agreements with colleges and agencies leaving a net cost of \$139,693. For this amount, the City will receive the services of 30 Interns in the Spring; 150 Interns in the Summer; and 40 Interns in the Fall. This is a total of 220 Interns for twelve week terms which work out to 52 man years which in turn work out to about \$2,690 per man year.

It would be appreciated if you would present this proposal to the Finance Committee for possible inclusion in the 1970 Budget. I would hope that we could give the Urban Corps Staff some indication as early as possible so that they can make their plans accordingly.

My own thought is that the Urban Corps concept has proven itself and is worthy of support if city finances will allow it.

O'Connell, Jr. to Mayor Allen, setting forth certain stipulations for the continuation of the Urban Corps internship program through December, 1969.

The problem appears to be whether the above letter might be agreed to and thereby become a contract in accordance with the terms of a resolution adopted October 6, 1969.

In an effort to understand the problem, I have examined your file on the Urban Corps and read considerable papers. I am still not certain that I fully comprehend it.

The resolution adopted October 8, 1969 states that "the Mayor is authorized to execute an agreement with the Southern Regional Education Board providing that the Board will assume all financial responsibility for the payroll costs of the Urban Corps for the fall 1969." The resolution further allows the payment of not more than \$8000.00 for interns that are used solely by the City.

I do not feel that simply having the Mayor sign Mr. O'Connell's letter agreeing to the terms therein would be sufficient under the circumstances. This is not to say that a contract cannot be raised

by the acceptance of a letter or the exchange of letters, but such a procedure is more suitable for private persons than for public bodies.

In order to satisfy the requirements of the resolution of October 8, 1969, an agreement containing specific details is necessary. At the same time, the document should be in the nature of a formal contract, not solely for the sake of formality, but for the sake of clarity.

According to my understanding, it appears that SREB officials had some objections to a proposed contract. It might be that some other approach will be acceptable to them and also satisfy the requirements of the resolution.

I remain available to assist you in this matter and await further instructions.

Reference is made to your memo of September 17, 1969, and Mr. George Berry's reply of September 18, 1969.

I wholeheartedly agree with Mr. Berry's comments and would like to further add that the City Charter requires that all funds of the City clear through the Revenue Collector's Office of the City. The Charter further requires that the Budget Commission is the only body that can anticipate additional revenue. The City as a result of a Charter provision has every employee on its payroll covered for fidelity bond purposes in an amount of \$25,000. Part of the bonding requirements is that all funds be centrally controlled and should carry the signature of the Mayor and the Director of Finance.

In view of these provisions, it is not legal for the Urban Corps to establish and maintain a private bank account.

I trust this additional information satisfactorily answers the questions raised in your memo of September 17.



PROGRESS REPORT

TO THE

ATLANTA URBAN CORPS, INC., BOARD OF TRUSTEES

The Atlanta U.ban Corps completed its first quarter of operation on August 22, climaxing a ten week intern program utilizing students in urban problems . The program involved 225 students from 43 different colleges. Approximately 80% of these students were from Atlanta area colleges. Interns were placed in 35 public interest non-profit agencies and 15 departments of the City of Atlanta. Approximately 45% of the students were black and 55% white. A typical example of a city department internship was a team of 15 students doing research and data analysis in the City sanitation department. Others served on the Mayor's staff doing research and another example was students compiling financial information for possible tax legislation in the City of Atlanta. The private public-interest agencies tended to utilize students more in the social and humanistic disciplines such as counseling or working in recreation programs involving young people and actual communities. A typical example is an intern serving in the Emmaus House teaching children from deprived neighborhoods basic reading skills and education courses during the summer. Another example involved ten students in a mentally retarded children's camp sponsored by the Decatur-Dekalb YMCA.

This summer our operating budgets was approximately \$200,000 broken down as follows.

\$52,000 Appropreation from City of Atlanta \$20,000 Southern Regional Education Board

\$13,000	Private Business Contributors	
\$75,000	College Work-Study Program (Grants from the Office of Education through Individual Colleges)	
\$20,000	Private Public -interest Agencies	
\$20,000	Volunteers in Service to America	

Approximately half, or 114 students, were sponsored under the College Work-Study program, which is a federally sponsored program of the Office of Education whereby the college pays 80% of the intern's stipend, with the agency involved supplying the remaining 20%. The College Work-Study program is available to every public college and grants vary according to requests and needs of the colleges involved. The student financial aid officer is in charge of these funds of each campus and can allocate them as he desires to "off-campus non-profit agencies" such as the Atlanta Urban Corps. This summer we were fortunate in persuading financial aid officers to contribute heavily to the Atlanta Urban Corps, and evidently this figure will rise apprecialby next year. Interns salaries were \$72.000 (1.80/hr) weekly for freshman and sophomores, \$88.00 (\$2.20/hr) weekly for juniors and seniors and \$100.00 (\$2.50/hr) for graduate students.

We received 880 student applications for the summer program giving a very good indication that students are indeed very interested in participating in summer internships and college-community involvement programs. We received 300 requests from city departments and public interest-agencies requesting interns to serve as assistants during the summer. Unfortunately these position requests usually can't be paid for at full cost by the agency, hence, the need for private donations for non-work-study interns. We have already received over 75 requests for interns to serve during the academic program,

This summer the Urban Corps was administered by a student staff of 15 people whose abilities and dedication are directly attributable to the program's success. We started extremely late in the academic year and ended up with a very substantial program involving numerous colleges and students. We were fortunate that much ground work had been done in Atlanta and many of the organizations whose resources were needed had been involved early in the planning and understood the aspects of the program well. This was due to hard work done by many students in Atlanta from various colleges. A special note of thanks should go to Dave Whelan, Mark Dash and Rich Speer, whose early work in contacting the Board of Trustees and especially fund raising later proved beneficial to the Urban Corps. We found that these students, through contacting various colleges, were primarily responsible for the high number of applications we received with little. or no publicity.

This summer the Urban Corps has administratively operated under the City of Atlanta and the Southern Regional Education Board, primarily for contractura1 agreements purposes with the agencies and for legal contracts with the colleges. A very large in determining administrative responsibility was in the question of who served as the paymaster. The City was most cooperative this summer in absorbing a deficit spending situation whereby it absorbed the cost of the student's stipend until colleges could reimburse them. Also, many agencies were tardy in paying their share of the student's stipend. In some cases this meant a debt of \$60,000 which was carried over a three or four week period. This is the primary problem in utilizing a group such as the Board of Trustees in handling administrative difficulties that arise in the Urban Corps. If the Board of Trustees had a large bank account and could absorb tremendous deficits within a short period of time, no difficulty would arise. Otherwise, the City must be retained in some paymaster role or legal role for contractural authority. (In my opinion, the Urban Corps as we know it today, should operate under its present system through the summer of 1970 with the Board of Trustees taking ultimate control in September of 1970.) The financial and payroll problems incurred this : summer point to the need for extensive planning and lead time before the Trustees

take over the Urban Corps operation.

A special note of thanks should go to Dan Sweat, who helped us with space, payroll problems, contractural problems, and staff expenses during the initial summer program. Unfortunately, those elected officials at City Hall do not completely agree with Mr. Sweat. The City Finance Committee naturally closely scruntinizes our monetary requests. From a purely financial point of view these members of the Board of Aldermen do not agree that we should have educational counseling as they put no emphasis on the educational aspects of the program. These financial people interpret the Urban Corps as a cheap summer employment program for summer months only. This again is an indication that more input is needed from the colleges and those "education" spectrums of the community. Naturally the more money that comes in from other sources the more autonomy we may have in making expenditures.

From the first ideas of the Urban Corps to its actual implementations, there has been a tremendous emphasis on student input. Presently, we have a high degree of student participation in that all of our staff members are students. In my opinion, student représentation should be included on the Board of Trustees, but these students should come from the ranks of those who have served as Urban Corps interns, rather than having student governments elect any interested student to serve in that role. From operational experiences this summer, we have found that the program is best administered by one individual reporting to a small group of people rather than the original proposal of having two people head the organization, one in the role of a student director and one in the role of the staff director.

My suggestion for continuing the student input is to make sure that the Director is a young person, preferably a graduate student himself and that the Board of Trustees function more closely to the Urban Corps.

Presently, the Atlanta Urban Corps, Inc., exists only on paper. The Internal

Revenue Service has granted the Atlanta Urban Corps, Inc., a tax exemption status. The next step for the Board of Trustees is to make the by-laws more specific. Also, the membership of the Board of Trustees should be revised to make sure that all sectors of the community are equally involved and that no sector is overweighed, specifically in reference to the resources needed to operate the Urban Corps.

I am leaving to attend Graduate School at Harvard University, but have found a replacement who is very interested in the Urban Corps and knows a lot about it from his experience this summer. This student was recruited and interviewed by myself, Bill Ramsay, Dan Sweat and others intimately involved in the Urban Corps.

Mr. Ken Millwood is a graduate of the University of Georgia School of Journalism and is presently pursuing a Master's Degree in Georgia State's Night School. Ken was Urban Corps Public Relations Director this summer and did an excellent job as you probably know if you saw news clippings about the Urban Corps this summer. The present plan of the Urban Corps is to administratively report to the City and the Southern Regional Education Board as we have done in the past.

There are many possibilities on the horizon for future operations as far as finance and other resources are concerned. The Urban Observatory, a college affiliated research group of the Mayor's Office, has asked for a grant of \$30,000 to be given to the Urban Corps for operational expenses. This grant has not yet been approved by HEW. The United States Commissioner of Education, Mr. James E. Allen, Jr., had indicated very strong support from HEW to the Urban Corps and other internship programs. Mr. Allen made a statement recently to Urban Corps interns saying that roughly half-of the college work-study allocations should be spent in such involvement programs between the college and the

and the community. The Office of Education is presently implementing this guideline which means that next year the Urban Corps in Atlanta will absorb approximately \$700,000 of College Work-Study funding. We anticipate roughly 1,000 summer interns next year and 100 interns during the academic year. We are also working closely with colleges in trying to persuade them to grant academic credit with guidelines to insure that educational experience is indeed received. We are running into quite a bit of difficulty in the area of academic credit and welcome help from the members of the Board of Trustees.

A very unique part of the Atlanta Urban Corps is its Field and Education

Staff. This summer this group of students staffers has structured seminars

and visited with interns discussing urban problems as well as personal difficul
ties that may arise on the job. The Field and Education Staff should be an

integral part of the Urban Corps from now on, since it has proved so beneficial

for the summer operation. Typical examples of seminars have ranged from speakers

such as Joe Boone, Civil Rights Leader in Atlanta; to Members of the Mayor's

Staff working on Urban problems. We have tried to pick people from all spectrums

of the urban scene to give interns a good idea of what our problems are in Atlanta

and what is being done and what should be done about them.

As an integral part of the internship program this summer, each student submitted a final report detailing his experiences and recommendations about the Urban Corps and about his agency of city department. These reports have been used by agencies and city government in obtaining grants and reviewing their administrative and program operation. Other reports have given the Board of Aldermen plans for urban renewal in Plunkettown and many private agencies have used these reports in raising funds and improving their operation. A catalogue of these reports is available for those persons interested and each report

is on file in the Urban Corps office.

The Atlanta Urban Corps has attained national prestige this first year due to the many people in Atlanta who were interested in its success. We have received unanticipated amounts of publicity from the local press to the nationally syndicated newspapers. We are the only program of our type which has been able to obtain support from the business community, educational community, the government, and public service community. The greatest factor for success now rests with the educational and governmental sector. I urge those members of the business group on our Board of Trustees and other influential members to try to persuade the new Mayor to support the Urban Corps as much as Mayor Allen has. Also, we are in desperate need of funds as usual. Members of the business community should help our student staff members in raising these funds.

The Urban Corps has proven that students can indeed contribute to solving the urban problems of Atlanta. We hope this is only the beginning and that further and more sophisticated cooperation can become evident between the college and its community in the near future. Mr. Ken Millwood, the new Director, will be in touch with you a later date to outline specific plans and progress reports of the Urban Corps. We welcome any of you to visit our office at any time. We are located upstairs in the Old City Auditorium.

The Fall Program of the Atlanta Urban Corps is now in operation. Fifty - five (55) to sixty-five (65) interns will be placed this fall. As in the past, the sponsorship of Atlanta Urban Corps is shared by SREB and the City of Atlanta. The internships are to begin September 29, 1969, and run for twelve (12) weeks until December 19, 1969.

It has come to the attention of The Atlanta Urban League that the Federal Housing Administration is anticipating rehabilitation and sale of approximately 1,000 units of foreclosed Section 608 war housing in DeKalb County, Georgia. Reportedly, the disposition of the Oglethorpe Group Apartments is delayed, at the moment, by a suit against foreclosure brought by the previous owners of the project; however, it appears that the Federal Housing Administration has proceeded with plans for rehabilitation and disposition.

We are concerned that there are strong political and economic pressures attempting to prevent additional ownership by minority citizens in this part of the Atlanta Metropolitan area. We feel that an investigation into the racial implications and prejudices inherent in a commercial, profit motivated disposition is warranted. This project could be considered a regional, and certainly a local, resource in its application towards fulfilling the housing needs of poor and minority citizens.

The sale of the above-mentioned project for a profitable return to FHA is abhorrent to us and we strongly recommend your consideration of alternate proposals.

The program outlined by Interfaith, Inc., a local nonprofit church sponsored housing development corporation, deserves your firm support. Such a proposal would maximize ownership and participation in rehabilitation by minority citizens and would provide a wide range of income distribution within the project itself.

Final Internship Reports - Summer Urban Corps Workers

Dear Mr. Millwood:

We have carefully reviewed final internship reports for Water Department summer Urban Corps workers, and they are returned herewith. Some worthwhile contributions were made by the interns.

After analyzing the program, it appears that several misleading ideas adversely influenced the students:

- 1. Some associated the name Urban Corps with the masses of underprivileged children and assumed that their jobs would be tied in with these "runny nose children", as one of them put it.
- 2. Others thought that they would be involved in "sky blue" research projects relative to social or physical changes.

Most of our Water Department work involves down to earth, utilitarian programs related to providing pure water to 650,000 citizen-customers. This requires willing workers with positive attitudes. Most of the summer workers exhibited negative, critical attitudes.

It is my feeling that a clear understanding of objectives and attitudes required for an effective program should be worked out.

Subject: Urban Corps Enrollees for Fall

As a result of the action of the Finance Committee appropriating \$12,000 for administrative costs, the Urban Corps is progressing on its assigned task of operating an abbreviated program this fall and planning a larger program for this coming year for presentation to the City this fall during the regular budget process.

They have canvassed City Departments and have determined that ten departments and/or agencies have requested enrollees for this fall. The attached schedule sets forth requests from the ten departments for 24 enrollees. Note that since the list was typed, the Water Department has reduced its request to I full-time enrollee rather than the 2 full-time and three part-time that are on the list.

This is to request that you take whatever action is necessary to present this question to the proper authorities to get a decision on whether this amount of funds can be utilized for this purpose and then take the necessary action to make such funds available to the Urban Corps who will then authorize the expenditure to the Southern Regional Education Board who will act as paymaster this fall. It is the understanding of the Urban Corps that presently appropriated salary funds of the benefiting departments can be utilized for this purpose.

We have reviewed the requests of the Departments for these enrollees, and they appear to be reasonable.
