



This will confirm our conversation on Friday, June 11, with Mosers.
Lenders, Delius, and Sheats regarding the City's interests in the
Adamsville Health Center property. As pointed out by Mr. Lenders and
Mr. Delius at this neeting, the City is not in a position to abandon
its building on this site at anytime in the foreseeable future. They consider that under the Plan of Improvement the property will go to the City
without any encumbrance in 1369 following the expiration of the Hill Burton
commitments.

In view of this, we will have to work out our plans for the expansion of the health center on the property that we have at the moment plus any property that we might be able to acquire to the south of the present site.

As we agreed at the meeting, we will follow the following course:

- (1) You will proceed to contact the State Health Department and relate the above information to them. We will request them to approve the project with the understanding that the County will purchase additional land to the south. If this is acceptable to them, then we will have to bring the matter to the County Commission, preferably next Wednesday, June 16.
- (2) I am requesting the Department of Planning to work with the Land Agent and the Architect to determine precisely what property should be purchased to the south of the present site. At our meeting, Mr. Landers pointed out that the City was going to have to locate a fire station in this area. If sufficient land exists between the present site boundary and Gordon Road, he stated that the City would be interested in attempting to work out a joint purchase of the land, with the Gordon Road frontage being used as a location for a fire station. Before any decisions are made on site purchase, we should determine if there is adequate land for a fire station end, if so, whether the City is interested in a joint purchase.

(3) Assuming that the State will agree to the above, we still have the problem of getting their agreement to the proposed plan prepared by Mr. Deadmore. While it might be possible to design a simpler addition to the building, I believe that the plan proposed by Mr. Deadmore would provide a far more satisfactory final product. As noted Friday, this is a repidly grawing area. We can look forward to a heavy concentration of population. I think it is important that we consider this when making decisions on the size of the health center. I know that you will drive these points home to the State Health Department officials.

It is important that we get as much done as possible prior to the meeting on Wednesday so that we are in a position to discuss the entire situation with the Commission. Please keep me advised of your progress.

The County is planning to expand the Adamsville Health Center in order to meet the urgent needs of this growing community, but the presence of the City Recreation Center attached to the existing health center building makes it somewhat difficult to plan an adequate and efficient addition. The County is also concerned about the effect this recreation center will have on parking facilities and future expansions which will undoubtedly be necessary.

On the other hand, I gather from conversations with you and your staff that you find the recreation building and the situation in which you have to use it far from ideal, and that the City too realizes the pressing need for better recreational facilities for this area.

In view of our mutual dissatisfaction with the present arrangements and our need to plan better for the future, the County would be interested in considering a proposal from you under which the City would give up the recreation center in return for some other property or consideration which you might find more useful. We have in mind that while you might not be able to relinquish use of this building immediately, we could work out some arrangement whereby the County could secure clear title for the recreation building now in order to facilitate the approval of a Federal grant for expanding the health center.

This letter is in response to your phone call and letter of August 13, 1964, concerning the above.

As I understand the situation, under the "Plan of Improvement" in 1952 the City of Atlanta assumed operation of the Recreation Building and the County continued managing the Health Center, all at the same location.

Around the year 1949, according to the County, the entire parcel of land was dedicated for public health purposes until 1969, in order to qualify for State and Federal funds. You outlined that the County desires to expand the Health Center, which would involve rededication for 20 years.

It is my opinion that when the "Plan of Improvement' took effect in 1952 that the City of Atlanta acquired fee simple title to the property used by the Recreation Building subject to any incumberances existing upon said property at the said time.

It is my further opinion that the County does not have the legal right or authority to rededicate the recreation property for an additional 20 years inasmuch as any interest the County Mr. Jack C. Delius Page #2

had in said property was extinguished by the Legislature under the "Plan of Improvement."

It is my further opinion that the City of Atlanta would not have the authority to dedicate park property for a period of 20 years for public health purposes.

The two buildings are connected by a covered walk. The Recreation Center is referred to as Adamsville Recreation Center.

In accordance with your suggestion, we met this morning at the Adamsville Health Center with Mr. Jack Delius, Manager of the Atlanta Perks Department, other members of his staff and Mr. Paul Ivey, City Land Agent, and reached the following agreement regarding the joint use of this property:

- 1) The County would have a free hand in developing that part of the property lying west of the back (east) wall of the health center building.
- 2) Any part of the health center addition extending eastward of the back (east) wall of the health center would be so designed as not to interfere with access to or the normal use of the recreation center building.
- 3) The County would have the right to pave and use the area in the rear of the recreation center for parking purposes provided: a) That the City would use this area for recreational purposes when it was not in use for parking, and b) That the existing barbecue pavilion in this area be preserved or relocated so that it could centinue to be used in connection with the recreation center.
- 4) In view of the existing dedication of this entire parcel of land to public health purposes until 1969, and the requirement that it be rededicated to public health purposes if we are to obtain State and Federal aid for the addition, it was agreed that no part of the property would be conveyed to the City, but that this agreement would be reduced to writing and treated as a Centlemen's agreement rather than a legal encumberance, subject to the approval of both parties.

Although both Mr. Delius and I recognized that we do not have the authority to cormit our respective governments, we agreed to the above understanding as satisfactory from the viewpoint of our respective departments.

Mr. Delius, his staff and Mr. Ivey were all very considerate and cooperative, and are to be commended heartily for their willingness to work out a mutually acceptable accommodation.

We are very grateful to you for expediting the amicable resolution of this problem.

This will acknowledge receipt of your letter of July 10 concerning the property in Adamsville that is being used as a recreational center wherein you ask for an opinion as to the rights of the City has in and to that certain tract of land in Land Lot 243 of the 14th District of Fulton County, Georgia, that is currently being used by the City Parks Department for recreational purposes. Section 4(a) of the 1951 Ga. Laws at page 3113 provides as follows:

"The legal title to all real property owned by Fulton County within the corporate limits of the City of Atlanta as the same may be extended on or after the date this Act is approved and assigned to or used in connection with a parks and recreational system on the date this Act is approved, shall on January 1, 1952 pass to the City of Atlanta with all rights and appurtenances thereto and subject to all liens and emcumbrances thereon, unless conveyed by deed to said City of Atlanta at an earlier date. If no earlier conveyance is made, the proper authorities of Fulton County are directed in order to clarify the record title to said property to execute and deliver to the City of Atlanta on January 1, 1952, or as soon thereafter as practicable, a deed or deeds containing the legal description of said property, but such deeds shall not be necessary to effect conveyance of the legal title."

It would appear to me from the facts that you have furnished that this property has been assigned to be used in connection with a recreational system and that legal title to such property passed to the City of Atlanta on January 1, 1952.

Thank you very much for your letter of February 24, 1969, which was received on March 6, 1969 regarding the need for a swimming pool at Anderson Park. I address this letter primarily to your since your name appeared first on the letter of petition and I am taking the liberty of sending carbon copies to Messrs. Miller and Hart since this office has addresses on these two gentlemen. In addition, I am taking the liberty of sending carbon copies of this letter along with copies of yours to the members of the Park Committee of the Board of Aldermen and staff members of this department.

Out of the fifteen swimming pools currently operated by the City of Atlanta, five of them do not meet modern Fulton County Health Department specifications. These pools are Piedmont, Maddox, Washington, Oakland City, and Mozley. Every conceivable attempt is made to maintain sufficient maximum hygenic standards in that these five mentioned pools are not presently filtered. Each and every one of them is scheduled for replacement in our 15 year Park and Recreation Plan.

We particularly appreciated your kind remarks concerning development which has taken place at Anderson Park and we fully agree with you that this location does need a swimming pool. However, a large percentage of the 1969 Park Improvement Budget has been earmarked for Model Cities and urban beautification. A total of some 32 different projects are listed which will, we hope, be completed in 1969. This will utilize every penny of funds made available to this department by the Board of Aldermen for capital improvements.

When Mr. W. Z. Miller recently came before the Parks Committee of the Board of Aldermen requesting that a swimming pool be built at the earliest possible time at Anderson Park, several members of the Committee stated that they would make an attempt or at least request additional capital improvement funds for this department from the new bond issue authorized late last year. As I understand it, a number of capital projects from all twenty-odd departments are being listed now and priorities will shortly be established as to the utilization of this bond money. It must cover sewers, streets, bridges, etc.; not just parks.

A member of this department, Mr. Charles Devon of our Park Engineering Division, was present when a community services coordinator stated at a meeting held in your community last year that plans did include a swimming pool and bathhouse for Anderson Park to be completed during 1969. Mr. Devon was completely shocked at this statement and corrected the man immediately thereafter. Not even the undersigned, as General Manager of Parks, has the authority to obligate the City of Atlanta to projects where no funds exist.

Please be assured that I do have a definite personal interest in the future growth of recreation facilities for the Dixie Hills area and in particular Anderson Park. You can indeed count on me to the extent that I am allowed to construct new items within the capacity of available funds.

Dear Mr. Leftwich:

Pursuant to the several converstions you have held with the undersigned, along with the interest expressed. by Mayor Ivan Allen, Jr., I asked Miss Dorothy Yarbrough of our Recreation Division to compute as accurately as possible the cost of operating our resident camp and the wilderness camp at Lake Allatoona. I have taken the liberty of xeroxing her response which includes a breakdown for cost per resident camper at \$42.35 for a five day period and a cost for wilderness resident camper of \$28.20 for a five day period.

I have discussed very thoroughly with all the Recreation Supervisors the opinions expressed by you and Mayor Allen as to the expenses involved in operating a camp, particularly one that is some forty-five miles from City Hall. I have made the suggestion that possibly we should increase the number of participants and lower the duration of stay in order to reduce the per camper cost. I still feel there is some merit in this suggestion; however, the supervisors representing the five areas of Atlanta without exception state that citizens in their areas of Atlanta were very pleased with the five day schedule and would prefer it not to be reduced.

We are carefully avoiding the expenditure of any City funds for anything other than absolute basic maintenance and upkeep at both our camping facilities. We have however, included in our 1969 proposal to EOA provisions for camping. It seems that OEO in Washington places great emphasis on camping experience and since we have conducted this program with Federal funds for the last several years, I feel it in the best interest not to remove it during 1969.

Thank you for the copy of your letter to the Military Aircraft Storage and Disposition Center (MASDC), Davis Monthan AFB, Arizona 85707. Please note the enclosed letter from MASDC and the brochure provided by the Center on detailed instructions for the acquisition, disassembly, and transportation of a donated USAF aircraft.

Regarding the F-86F series aircraft which Colonel R. P. Collins identifies in his letter as being available in Arizona, I believe that you would find this single-engine jet fighter suitable for a playground. Also, since the Georgia Air National Guard at Dobbins AFB previously operated the F-86D aircraft, their maintenance personnel should be able to assist in the handling of an F-86F. This leads to considering the Georgia Air National Guard, namely the 116th Military Airlift Wing (ANG) to allow Brigadier General Thompson time to arrange for use of ANG airlift for this civic project. The State of Georgia, as well as the City of Atlanta, should receive favorable publicity along with Georgia Tech in this overall project.

Dear Ferrin and Tom:

This letter concerns a problem we are having with Fulton County involving certain County and City property known as the Adamsville Health/Recreation Center, and also land now owned by Fulton County (and sometimes referred to as the "Nelson property") adjacent to Bagley Park in the Northeast section of our City; finally, as part of the overall package, this letter also concerns an undeveloped park site in Northwest Atlanta, known as the Sandy Creek Park Site. The latter is adjacent to the Fulton County Airport.

Let me say at the onset that the Parks Committee is aware that Mr. Choyce is the Attorney assigned to the Parks Department, but they feel since considerable amount of research apparently was done by Mr. Mathews in rendering a decision concerning Adamsville, that this letter should be addressed to both of you gentlemen.

I am enclosing Xerox copies of the entire Adamsville, Bagley, and Sandy Creek Park files. I have asked my secretary to place these copies in chronological order and, to further simplify the matter, I have attempted to extract from the Adamsville file all the pertinent information as to who said what, and when. It is included as an enclosure to this letter.

To summarize the Adamsville Health/Recreation Center situation, there exists at 3404 Del Mar Lane, S. W., a small parcel of property which contains two buildings connected by a breezeway. One of the buildings is a recreation center operated by the City of Atlanta ever since the Plan of Improvement. The other is a now recently vacated Fulton County Health Clinic. We contend that we already own half of the propertynamely, the Recreation Center, and would like to acquire the other half from Fulton County at some reasonable value. Fulton County generally claims that we have no interest in this property because of a twenty-year covenant placed on it in 1949 to secure Federal and State Health money, said covenant expiring in 1969. Note that the covenant was placed on the property prior to the Plan of Improvement.

You have rendered a legal opinion stating that we do own half the property, and your opinion has been substantiated by a legal opinion rendered to Mr. Paul Ivey by Mr. Ralph Jenkins, of your office. The County Attorney has advised me that he is in the process of selling this property to a private individual for its recently appraised value of \$85,000.00 if we don't make up our minds quickly as to what we intend to do about buying it ourselves. He made it clear that his position is the City has no interest in the property. However, shortly before Mr. Earl Landers' retirement, Mr. Landers contacted the County Attorney and apparently worked out an agreement where the City would have to pay for only half the appraised value. You will note, among the Xerox copies attached, my copy of Mr. Landers' letter to Mr. Harold Sheats.

Problem No. 2 involved a small parcel of land adjacent to Bagley Park, which for years we thought belonged to the City of Atlanta. Some time ago, prior to discovering who really owned the land, my department installed a number of white-way poles which lie on the property by a matter of a few inches. By the time we discovered that we did not own the land, Fulton County let it be known that they were going to widen Pharr Road. Mr. Paul Ivey, our Land Agent, reached an agreement with the County whereby the County would buy this private property, generally known as the "Nelson property," and would take off the front of it that which they needed for the widening of Pharr Road, then would transfer this property to the City of Atlanta at their net cost. In turn, the City would transfer to the County the frontage of Bagley Park, also needed for the widening of Pharr Road. The net results of this transaction would be that the City of Atlanta would pay to Fulton County approximately \$2,500.00. Ever since 1964 Mr. Ivey has been making repeated efforts to get Fulton County to go ahead and prepare a deed to transfer the "Nelson property" to the City. Mr. Ivey has let it be known that the City is ready to buy the property. However, Mr. Ivey reports that he has been put off on numerous occasions by various representatives of the County. The County has now contacted Mr. Ivey and is asking, "Why in the world doesn't the City go ahead and buy it," and have now placed the value at \$3,500.00. The County's representative says that the land is now worth that amount and, if we wish to buy it, that is what it is going to cost us.

Thrown into this is a small and rather minor situation where the County desires to acquire from the City what we call the Sandy Creek Park Site in Northwest Atlanta. The County needs the land to expand their clear zone for the Fulton County Airport. We are perfectly willing to accommodate Fulton County in selling them Sandy Creek Park Site at the appraised value so that they might expand the runways. The property was deeded to the City of Atlanta with a number of restrictions and easements and is in the flood plains; therefore we would not be losing any particularly valuable piece of park property.

What the City of Atlanta would like to do is to purchase from Fulton County their half of the Adamsville/Health Recreation property for approximately \$42,500.00, to pay them approximately \$2,500.00 for the "Nelson property" adjacent to Bagley Park, and to sell the County the Sandy Creek Park Site for its appraised value. What the County apparently proposes to do is to sell the City Adamsville for \$85,000.00, the "Nelson property" for \$3,500.00, and to pay the City the exact appraisal for the Sandy Creek Park Site property.

It is the opinion of the Parks Committee of the Board of Aldermen that every possible effort has been made to settle the above in a friendly and fair manner and we wish to do nothing whatsoever that would disrupt friendly relations between our sister government. However, the Parks Committee apparently has grown quite weary of the discussions and problems arising from these transactions and has instructed me to proceed to turn the matter over to you to be settled from the legal standpoint.

Alderman Leftwich has expressed a willingness on his part to go with you to Fulton County and attempt to settle this matter; however the Parks Committee is so disgusted with the whole affair that they would be perfectly happy to let the courts decide the Adamsville and Bagley situation. Apparently, at this point, we are under no legal compulsion to sell the Sandy Creek Park Site to Fulton County although possibly they have the right of condemnation in the expansion of their public airport.

I know both of you gentlemen are busy and so we particularly appreciate your assistance, and I am

I have read a copy of your letter of August 8, 1969, to Mr. Charles L. Davis regarding a request from HUD.

On or about June 30, 1969, we received a form letter dated June 17, 1969, addressed to all agencies participating in the Open Space Land Program. Enclosed with the letter were HUD Handbook No. 1970.8 and several forms entitled "Combined Cost Control and State of Accountability". The letter stated that this was a new report that would be required by HUD semi-annually on all open space projects in the future. All reports should be sent to HUD within 10 days following the reporting period and the first reports were to be for the six months ending June 30, 1969. Mr. Carl Ryals and I immediately contacted Miss Patricia May in the office of Mr. Thomas Armstrong. Miss May is our liaison with HUD for all open space land projects. We talked with Miss May and others in Mr. Armstrong's office at length regarding these new forms in an effort to determine how they were to be completed and exactly what information HUD needed. The new reporting forms were also new to the HUD Regional Office and Miss May stated that we did not need to worry about the deadline for this first reporting period since she realized that we would need some time to set up procedures for handling the reporting forms.

Mr. Ryals and I determined that the forms should be completed by the Department of Finance and that Mrs. Linda Anderson would probably be the person to handle this. We were unable to arrange a meeting with Mrs. Anderson prior to her leaving on vacation the last week in July and first week in August. On the first day of her return on August 11, 1969, we met with Mrs. Anderson in the Department of Finance. familiar with these new forms and agreed that the Department of Finance would handle this type of report for all departments regarding Federal grants. She had already been in touch with Miss May concerning other grant programs and new reporting forms. It was decided that we should work closely with Mrs. Anderson in keeping her informed on all Open Space Land projects and their status. We are presently compiling information on all Open Space projects for which we have not received grant payments and we will get this information to Mrs. Anderson as quickly as possible.

In the meantime, Carl Ryals talked with Miss Patricia May again on August 8, 1969, and advised her that we were going to meet with Mrs. Anderson to work out a procedure for handling the reports. At that time, Miss May again reiterated that they understood our problems since the forms were new and that we didn't need to worry about not getting them in on time this first reporting period.

Apparently, Mr. Thomas Armstrong was not aware that we had been in touch with his office regarding these forms.

We will assist the Department of Finance in every way possible in order to complete these forms and get them to the HUD Regional Office.

Dear Mr. Shaw:

Thank you very much for your recent letter to Mayor Ivan Allen, Jr., which has been forwarded to this department.

I, too, sincerely appreciate your bringing this matter to my attention and you may rest assured a full investigation is under way regarding the use of the word "nigger" twice in the presence of out-of-town guests and tourists attending the Cyclorama lecture.

You are certainly right that there is a definite lack of sophistication and culture on the part of some of the Cyclorama lecturers. I hesitate to make this admission, but it is a fact and one that has been vividly brought to the attention of the City for many years. On one occasion when a vacancy existed at the Cyclorama, the Personnel Department somehow failed to list the salary in the want ads. The applicants who responded to the advertisement were well-groomed, educated ladies -- the type you would typically expect to run into when buying a plane ticket or renting a U-Drive-It. This is the type of employee we would hope to have at the Cyclorama, but the present salary schedule simply will not attract that type of person. I will say in some limited defense of the ladies presently assigned to Grant Park that they have, in most instances, displayed a keen interest in their work. Several of them have traveled (at their own expense) to meet various individuals who worked on the foreground and on the painting itself.

Each year we have approximately 300,000 paid visitors go through the Cyclorama and out of that number we will receive some six complaints in writing. This is six complaints too many, for I fully realize that for every citizen who will take time, as you have done, to bring a problem to the attention of the City, there are hundreds who are indifferent or who will not take the trouble. Thus, we stay constantly concerned about the conduct of all of our employees in the various eleven division of this department. The reoccuring

complaint on the part of most visitors who do write us is that the attendants were "rude."

We have insisted to our employees, who were under Civil Service, that the Cyclorama is one place that most all visitors to Atlanta go. Thus, in many cases it is the only impression a stranger will receive of our community. For something to spoil this impression or to injure the rapport we know an out-of-towner feels with our City is simply tragic. I pledge to you a renewed effort on my part to see that the Cyclorama is operated in some quality manner.

Finally, you can rest assured that the Assistant General Manager of Parks for field operations will personally attempt to determine which lecturer used the word "nigger," and disciplinary action will be brought against that person.
