White Man, Awaken!

Ten thousand American Negroes are now being trained and educated in Moseow as key men in what Stalin hopes will be a bloody Communist revolution in the U. S. A. These Negroes, through American Communists, are now establishing their contacts with every Negro community in the U. S. A.

Encouraged by the ignorant sentiment of foolish preachers, blind educators and political demagogues like Eleanor Roosevelt and Henry Wallace, these Negroes are cooperating with American political demagogues in an attempt to break down all social barriers between the black and white.

Among the many demands that they now make are the following:

1. They demand that all laws against intermarriage of black and white be repealed. It is the belief of the Communist that America will be easy to control if they can make of us a nation of mongrel mulattos.
2. Through the leadership of political demagogues and Communists, they would force Negro children and Negro young people in-

to white schools and colleges, which is the short cut into intermixture of black and white blood.

3. They would repeal all Jim Crow laws and compel white women to crowd into trains and busses with the blacks, thus breaking down all commonsense barriers designed to protect both races from the wrong kind of mixture.

WOULD FORCE MIXED SWIMMING

These pro-Stalin politicians who follow Henry Wallace and Eleanor Roosevelt have passed laws in certain states forbidding the erection of privately owned commercial swimming pools unless these swimming pools permit black and white to swim together.

PUBLIC TOILETS TO BE REMOVED

In Washington, D. C., public toilets for Negroes have been destroyed and Negroes now invade the toilet facilities originally erected for whites only. In view of the fact that nearly three-fourths of the Negro race is infected with venereal diseases, this fact alone makes such mixture of the races virtually criminal.

WHITE RACE TO DISAPPEAR?

A prominent political braintruster recently said in Washington: "It is only a matter of time when there will be no white race. The intermixture of black and white in the U. S. A. will remove the white race."

POLITICIANS CATER TO NEGRO SLUM VOTE

Political fakirs in both old parties are willing to sell the white man down the river in order to line up the Negro vote in the slums of the big cities in the North. It is only a matter of a few months until it is likely to be declared un-Constitutional and unlawful to send a child to a school for whites only, or a young man and a young woman to a college for whites only.

PRESIDENT HARRY TRUMAN

has allowed himself to give his O. K. to a so-called civil rights program which, in fact, was originally outlined by a conference of Negro Communists held in Detroit, Michigan. President

Truman was misled by a group of Northern politicians into believing that this program of social intermixture of black and white was smart politics.

This is no longer a political issue. It is a question of whether or not the white race is going to commit treason against itself and its America.

If the white people do not awaken and start voting for public officials who believe honestly and fearlessly in white supremacy, it is only a matter of time until the Negro vote in the South and the Southwest will be powerful enough to subdue and belittle and destroy the leadership of the white man.

We who believe in protecting the white man's interest do not hate the Negro and would not rob him of any rights guaranteed under the Constitution, but we are going to fight to the bitter end any attempt on the part of Washington politicians to force the following upon us:

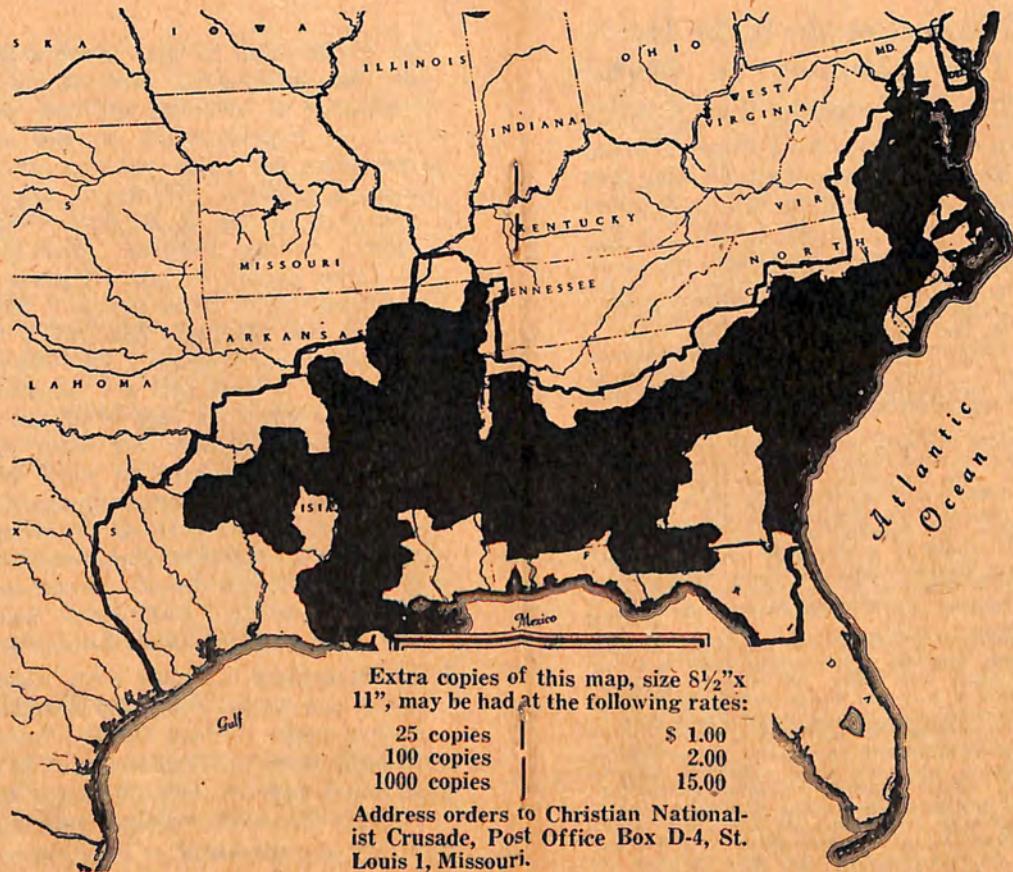
IN OTHER WORDS WE FIGHT

1. **The F. E. P. C.**—a law now being advocated by the leaders of both old parties in the North to force a white man to hire Negroes, whether

he wants them or not. Such a law is already on the statutes of New York State which makes it a criminal offense, punishable by fine or imprisonment, to ask any would-be employee his race, religion or color. It is even a criminal offense to ask how long he has been in the U. S., and whether he came from a foreign country. This is a trick law to force people to hire Negroes and Jewish refugees. The same political forces are trying to get the same kind of a law to apply to the whole Nation. To illustrate: If this law were to pass and a businessman in Oklahoma or Ohio, or any other state, called an employment agency for help and said, "I want five white girls to work in my office," he could be fined or imprisoned or both for saying "white." Or if he should say, "I want five Christian girls to work in my office," he could be fined or imprisoned or both for saying "Christian," on the grounds that this would offend the Jews.

2. **Intermarriage.** These revolutionists in our midst are anxious to create situations where it will make it easy for the weaker elements in both races to intermarry. Many states have statutes against this, but a Federal law is being advocated which would outlaw all at-

10 Million White People to be Driven From Their Homes to Make Room for Black Communist Soviet

American Negro Communists Now Being Trained In Moscow To Run Black Area, Thus Driving Out Whites And Enslaving Their Own Fellow Negroes

On the two preceding pages is an exact copy of a map taken out of the secret files of the Communist Party. The blacked-in area represents what the Communists hope some day (if they can promote a bloody revolution) will be the Negro Communist Soviet. It represents 120,000 square miles. About 10 million white people will have to be driven out of their homes. Among the leading cities that will be turned over completely to the Negroes will be Charleston, Atlanta, Shreveport, New Orleans, Savannah, as well as many others. The land which now belongs to the whites will be confiscated and turned over to the Red bureaucrats for control.

This plan was advocated within the past year by the Communist Negro member of the New York City Council, Benjamin J. Davis, Jr. Shortly before the war this plan was discussed in detail by Josef Stalin in an address before Lenin University where 2,000 American Communists are being trained now to run the United States. As late as February 10, 1947, a copy of a textbook, now being used in the Russian Army, was exhibited before the Congressional Committee for the Investigation of Un-American Activities. The title of the military textbook is **How to Bomb and Sabotage the U.S.A.**

It is to be observed that a border zone has been left adjacent to the blacked-in area. This border zone is to be populated by both black and white. Of course, all segregation will be outlawed and the white people as well as the blacks in this border zone will be under black rule. The revolutionary conspirators believe that the moment we have a period of unemployment, a general strike can be called, thus paralyzing telephone lines, railroads, electric power systems, and major factories. Trained revolutionists will immediately slaughter leadership and seize control. tempts to prevent intermarriage of black and white.

3. **Black and white mixture in schools.** Strange enough, our colleges are so full of Communists, pinks and pro-Russian propagandists that an alarming number of our public school teachers and college professors actually favor the mixture of black and white children and young people in schools. We white people must fight this to the death. To illustrate: Students of physiology know that a Negro boy comes into puberty much earlier than a white boy, and sex relationships on the part of Negro boys at the age of 10 is not uncommon. White people must not permit these blacks to be turned loose on our little school girls.
4. **Black bureaucrats.** The same politicians in both old parties who are attempting to commit the above atrocities against the white race think it is cute politics to appoint black bureaucrats to high office to have rule over us and to be put into positions of political authority. White men must oppose these cheap practices.
5. **Black rule in Southern States.** In the Southern states the Negroes equal and outnumber the whites in many communities. The Communist Party has a plot to make of these Southern states a Black Republic, ruled by Negroes now

being trained in Moscow. Truman's Communist-originated civil rights program is a scheme to destroy the authority of a state over its own affairs. It is expected even in this session of Congress that with the help of Eleanor Roosevelt Democrats, Northern Republicans and Communists that a law will be passed through Congress taking states rights away from these Southern states. Should this happen the black will overrun the whites in an arrogant and in a bloody bulldozing manner unequalled since Reconstruction days. Then if the whites resist, the U. S. Army will be sent into the South to enforce this black rule. This is just what Stalin, Henry Wallace and Eleanor Roosevelt desire. **It must never, never be.**

6. **Mixture in Transportation.** The average railroad coach and bus is filthy enough under present circumstances without mixing the blacks with the whites. Large numbers of these blacks reek with syphilis and gonorrhoea. This circumstance just does not permit the crowded intermixture with white people, especially in communities where the Negro population is large. Jim Crow must remain. It is a realistic program of transportation based on experience. It is bad enough for our daughters and wives to be crowded and pushed around and squeezed on busses and trains by the oc-

casional white moron without them being subjected to this offensive physical contact by black men.

ATTENTION: NEGROES

Christian white people do not hate Negroes. They merely want these Negroes to keep themselves in their place. That does not necessarily mean an unequal place. The Negroes should have good homes, good schools, good colleges, good churches, good clothes and decent facilities. White people who believe in social separation, if the Negro only knew it, are the Negro's best friends. The agitation for intermixture being led by the Communists, Eleanor Roosevelt, Henry Wallace and others, is creating a bad feeling among the white people, and it is piling up a backlog of ill-will which would not exist if the white man was not afraid that this intermixture was going to be forced upon him by demagogues, political fakirs and the actual makers of law. A few intelligent Negro leaders recognize the truth of this, but they have lost the political leadership of the Negro race, and the Negroes are following after the Henry Wallaces, the Eleanor Roosevelts and the leaders of the Communist Party. White people with any commonsense are going to resist this plot against their welfare.

Was Abraham a Jew?

No, Abraham was a Gentile. His father was a worshipper of idols. He not only worshipped idols, but he taught others to indulge in the same abomination.

And yet God loved Abraham. Indeed, so great was God's love for this remarkable man, that He honored him by calling him "my friend." And Abraham has come down to us in history as the only person in all creation whom God ever called "friend." What would you not give, dear reader, if you too could be called the friend of God? Sometimes we Jews get the false idea that just because we are Jews, we are therefore entitled to some sort of charmed existence, and that somehow God owes us eternal care and eternal life. Nothing could be further from the truth than this. The Jews in the times of the Lord Jesus Christ used to boast of this false security, but one day the prophet John the Baptist said to them:

"And think not to say within yourselves, We have Abraham to our father: for I say unto you, that God is able of these stones to raise up children unto Abraham" (Matt. 3:9).

In the days of Abraham, the word "Jew" was unknown. Such a thing as a Jewish nation was unheard of, and on every side were only Gentiles. And yet, God loved Abraham, a Gentile.

It is of supreme importance that every thinking Jew should find out why God loved Abraham. The answer is not hard to find, nor far to seek. It is found in our own Torah, in Genesis 15:6—

"And he believed in the Lord; and he counted it to him for righteousness."

At that time, Abraham was one hundred years old, and Sarah his wife was ninety years old. Both of them were beyond all human possibility of ever becoming parents. Yet God came to Abraham and

told him, "He that shall come forth out of thine own bowels shall be thine heir." And Abraham was just simple enough and trusting enough to believe that what God had said would come to pass, even though all human nature indicated that it would be an utter scientific impossibility.

Long before this incident, our Jewish Talmud tells us that Abraham had become disgusted with his father's and mother's idols; and although he had been brought up in his parents' religion, his own mind realized that that religion was vile and was in direct disobedience to the will of God. And Abraham as a young boy set his teeth, and turned his feet away from his father's home, and away from his own kindred, and went forth wherever God would lead him. If Abraham had not done that—if he had stayed by his father and mother, which was the easiest thing to do—would there be a Jewish nation today?

Listen, you rabbis! Hear us, you so-called Jewish leaders, who mislead thousands of innocent Jews! Don't ever again describe a Jew who becomes a believer in the Lord Jesus Christ as a "traitor to his mother's religion." If Abraham had not been a "traitor" to his mother's religion you would not be a rabbi today, and you would not be a Jewish leader today. It is only because we have had such "traitors" among us—men who have dared to stand for what is right, and who have gone down to death because of their fath—it is only because of such men among us that God did not destroy the Jewish nation many, many years ago because of the fulness of their iniquity.

God sent his only begotten Son into the world nearly two thousand years ago, thus providing an answer to Augur's question in the Hebrew Proverbs, "What is his (God's) son's name?" (Prov. 30:5). God asks us to believe in His Son as the only Saviour from our sins, as the only person through whom we may have eternal life. In asking us to do this, God has required from us exactly the same exercise of faith which He asked from Abraham

nearly four thousand years ago. Abraham believed God, but we Jews of today are so much smarter than Abraham that we refuse to believe God; and we quibble as to whether the Lord Jesus Christ could scientifically have been born of a virgin!

Thousands of Gentiles today are actually believing God, just as Abraham did of old. They are willing to believe God could and did cause the birth of the Lord Jesus Christ by the Virgin Mary. In so believing, these Gentiles are exercising exactly the same kind of faith that Abraham exercised, and so they have become, and God has called them, "the spiritual seed of Abraham." They are truly God's children, and they are putting to shame our Jewish nation, because they believe God, and our Jewish nation does not believe God.

The synagogues were crowded this Yom Kippur as in previous Yom Kippurs, and thousands of Jews fasted and prayed and cried to God the whole day long. But when the day was finished, did they have any assurance that their sins were forgiven? Did God answer their prayers? No! Listen to what God says in Isaiah 1:15.

"And when ye spread forth your hands, I will hide mine eyes from you: yea, when ye make many prayers, I will not hear: your hands are full of blood."

So, dear reader, you can keep on praying and fasting until the crack of doom, and your prayers will get no higher than the beautiful dome of your synagogue. The reason is that God has provided for you a way by which your prayers can be answered. If you will not take it, He cannot receive you. That way is through the Lord Jesus Christ, who said in John 14:6.

"I am the way, the truth, and the life: no man cometh unto the Father, but by me."

How long then will our Jewish people remain blind? How long will you allow only Gentiles to enjoy

all the blessings that God has promised to those who believe in the Lord Jesus Christ? Why not put God to the test? Just say in your own heart that you honestly do want to be a child of God, and that you honestly want to believe in the Lord Jesus Christ if God wants you so to believe. If you will do this sincerely, and then ask God from the bottom of your heart to show you whether or not the Lord Jesus Christ is truly your Saviour, we are satisfied to abide by the results you will receive. Will you try it? Then you will truly be a child of Abraham, because you will have the same faith in God's promises that Abraham had.

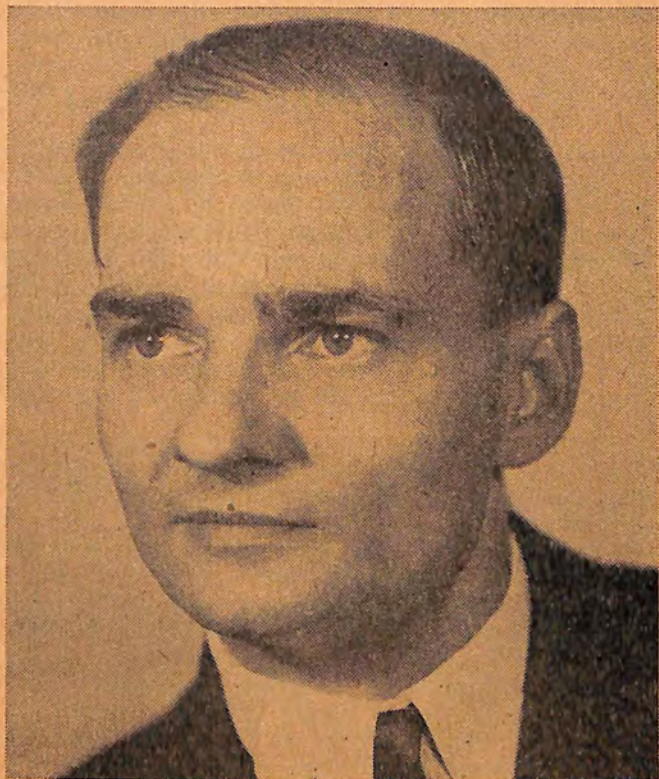

CHAIN - GANGED BY THE JEWISH GESTAPO

I am today under sentence of three years to the Georgia chain gang. Thanks to the friends of the Christian Nationalist Crusade, I am able to appeal the decision of the Supreme Court of the State of Georgia and am carrying my fight for liberty to the Supreme Court of the United States. I was framed by the organized Jews who bought perjured testimony, intimidated witnesses and corrupted public officials. This is the story of my life, my background and my experience with the Jewish gestapo.

In the Southland, as in the country as a whole, there are two basically opposing traditions forever engaged in a mortal struggle with each other to determine which is to be the guiding outlook of the future. The one is the supreme objective and tradition of the Whiteman; namely, the saving of his heritage, his self-respect and his future. The other tradition is the one of the Carpet-Bagger, Scalawag, and Negro Tyranny. I am a product of the Whiteman's tradition, and I am proud to proclaim that I fight in its ranks. In saving the Southland's tradition of the Whiteman we shall save America, and in saving America we shall save the whole White World from the starkly threatening menace of

tyranny and slavery under the Hammer and Sickle of World Communism. With these thoughts in mind early in 1946 I decided to do my part in preserving and helping the White community of the Southland, which is—expanded and projected into a higher level—the entire White community of America. The noble tradition of the Whiteman of the Southland must expand, and absorb unto itself the total tradition of the Whiteman of America. In this sense I feel that the Whiteman of the South has a distinct and historic mission to carry out, that he will succeed in accomplishing not alone an historic task for the South, but for America and the White World as a whole. The values of the Whiteman of the Southland are not gone with the wind, but are living and breathing realities, and upon them rest the future of the whole Whiteman's World. In the Southland—and almost in the Southland alone—the traditional Whiteman's Way of Life still lives in the daily living, and in the heart's places of deepest convictions, in the millions of her Whitemen and Whitewomen. In this redoubt of the old American faith, and way of life, still lives the spirit of the early Americans. We Whitemen of the South must take up the banners of this old faith and march under them from our redoubt into the task of winning the hearts of all of our White brethren in America. Early in 1946 these thoughts kept pounding into my consciousness. Several of my friends and I organized the Columbians. We rented an

office, installed a telephone, and on August 17, 1946 the State of Georgia granted us a charter and we were incorporated with the title "*The Columbians, Inc.*" with myself as president. We were incorporated as a political organization to work for the advancement of the White citizens of Georgia and America; we stated that we opposed Communism and believed in honoring American traditions. Our charter envisioned an organization of the nativist character. I proposed then, as I propose now, to fight the Whiteman's battle and let the chips fall where they will. We fought, however, the Zionist and Communist organizations, and associated movements, not on the basis of individuals within them but on the basis of the organized whole of these anti-American organizations. We proposed to elect men to public office who would represent the great mass of the White citizenry, men who would not be held in bondage by any of the special-interest groups, regardless of their nature whether economic, social, racial, cultural, or otherwise. We maintained that the Jews of the Zionist movement are primarily concerned with the future of the Jews as a nationality, and the future of Israel as a sovereign state. Their first loyalty—allegiance—cannot be to the American future, but to the Jewish future. They do not, therefore, form a part of our people; they should not have the right to hold public office in our society, and should not have the power to direct our political affairs. The Stars and Stripes is just the

flag representing the land in which they live; the flag for which they have real devotion is the Star of David flag of Israel. We fought for the repeal of the amendments, to the Constitution which were illegally ratified over the prostrate form of the Southland, while she was living in the terror of Negro bayonets under the direction of the hated Thad Stevens. We published the writings of Jefferson, Madison, Washington, and others among the Founding Fathers on the Negro Question. We believed that it is self-evident that the Negroes form a separate and distinct people from the White community, and all of our literature and speaking carried forward this thought. We favored the enactment of national legislation prohibiting intermarriage between the races, establishing the segregation pattern of the Southland throughout the country, and eventually the creation of a Negro homeland in Africa as was strongly advocated by Lincoln, and all of the Founding Fathers. We welcomed all members of the Whiteman's community into our fellowship, but we worked mainly among the underprivileged—those of our brothers and sisters that many of the politicians are wont to call "poor white trash." I despise that dirty attitude of narrow class-consciousness just as deeply as I despise the Marxist kind of class-consciousness. But regardless of what these vicious, anti-social and class-conscious Scalawags may think, the miserable slums will yet come down—profits or no profits to their

clients on the misery of a people—and the eroded acres in our rural areas will blossom forth with milk and honey and beautiful timberlands. The war has proved that our capacity to produce the things that our people need is practically unlimited. In one way or another our gigantic industrial machine is going to do just that. Under a patriotic leadership of our people this task can be accomplished along the traditional landmarks of the existing economic system. The alternative is Communism. In the future the class-consciousness of the right will perish along with the class-consciousness of the left. In spite of the smugness of some of our financially well-off White brethren, there are far fewer betrayers of the Whiteman's Way of Life among the simple and hard-working young textile workers and farmers than there are among their sons and daughters who go off to college and come back home confirmed Mongrelizers and Marxists.

OUR SYMBOLISM

The name "*Columbia*" is the poetical name of America. I designed the flag of the organization. Its background is the Battle Flag of the Confederacy, the square four foot by four foot flag of Lee and Jackson with the red field and the blue cross of St. Andrew. Over this background of the organization's flag is a large white disc and inscribed upon it is a red lightning-bolt. As we today sleep within the vicious embrace of alien octopus-coils, the lightning-

bolt and its thunder must awaken us to the heavy duties involved in the survival, spiritually and physically, of our people and race. This is the meaning of the lightning-bolt symbol. I also designed a lightning-bolt lapel insignia, and hundreds of shoulder insignia were embroidered by the faithful womenfolk of the organization. Most of the members were either veterans or workers and khaki clothing grew to be considered as the uniform of the organization.

OUR PUBLICATION

The Columbian organization published a paper titled "*The Thunderbolt*." The letters of the title were in the form of lightning, the design of which I took from a book titled "*The Son of Thunder*," an epic story revolving around the life of the great statesman of the South, the great champion of the Whiteman's Way of Life and one of the first thinkers to interpret it as a philosophy and world-outlook, the great Ante Bellum Whiteman, the great Robert Toombs, and was written by the well-known author and lecturer William W. Brewton, of College Park, Georgia, who is a very good friend of mine. Toombs was known as "*The Son of Thunder*" because of his great and powerful orations on the floor of the United States Senate. In designing the title of the paper I was anxious to remind our Whitefolk that we need oratorical giants today who can hurl out

thunderous oratorical lightning at our enemies, even more than we did four and five score years ago. We called upon our people to awaken.

WE HOLD A GREAT MEETING

Our people were thirsting to hear the truths which we gave them. We spoke straight from our hearts. At first the newspapers ignored us. But we were out to help our people, the great rank-and-file of the White people, and we were quite unconcerned about what the Jewish-controlled newspapers thought about us. Neither were we out to gain the plaudits of the Jewish and Negro peoples. Dan Duke, Assistant Attorney General of Georgia at the time, is a well-known Jew-puppet. He often goes to New York, sits with Negroes at banquets, and ascertains the wishes of the Jewish leaders, and the bigshots of the Association for the Advancement of Colored People. Duke about this time went to work with certain Jewish leaders and decided that the Columbians had to be stopped or he would not have a political future. On October 18 we attracted to our meeting a larger crowd than most of the politicians could muster. For several days we had advertised it with leaflets, given out in house-to-house distribution, and with our sound trucks. More than three thousand persons attended the meeting. We attacked Helen Mankin, who was running for Congress and making a strong appeal for Negro votes, and supported the late Eugene Talmadge, the venerable and well-known fighter for White Supremacy

in Georgia. I knew Mr. Talmadge and used to talk with him by the hours in his hotel suite in Atlanta. Not long before his death he called me and asked that I visit him. Before I could do so he was in the hospital and on the point of death. I have wondered many times why he made that call and the nature of the matter that he wished to discuss with me. But we not only discussed specific issues but general principles and ultimate objectives. The crowd howled and yelled approval. I knew when the meeting was over that the enemy was frantic. The *Anti-Defamation League of B'nai B'rith* and the *Non-Sectarian Anti-Nazi League* went to work. These are two of the deadly fangs of the Jewish-Gestapo octopus.

THE JEWISH-GESTAPO APPEARS

One day a man who said his name was James Falco and a woman who said her name was Renee Forrest appeared in our offices. John Roy Carlson, author of the smear books "*Undercover*" and "*The Plotters*"—who in reality is an Armenian mongrel named Derounian—was in Atlanta at the time giving lectures against Talmadge, and the Columbians. I knew these people were agents of the enemy at first sight. I was quite sure they were agents of Derounian, who was supposed to be writing another book, and that he wanted to devote a chapter to the Columbians, to which I had no objection. The trash dished out by Derounian, Winchell, and their ilk help the Whiteman's cause. These liars later said

they gained my confidence, but the fact is I had only one lengthy conversation with them. They were in our offices altogether only a few hours, and during that time they were closely watched by our officer workers. But we were sold-out from within our organization. Two of the young men—Ralph Childers and Lanier Waller—who were working in our offices did not know the meaning of what we were striving to accomplish. Later Lanier Waller, after he had broken with the Anti-Nazi League and signed an affidavit attesting to my innocence and those associated with me, told me the story I am about to relate showing how this Communist-front espionage organization used the good name of the State of Georgia to frame-up its enemies, by using some of the mongrelizer and scalawag officials as its puppets and stooges.

THE TECHNIQUE OF THE JEWISH-GESTAPO

The real name of James Falco is Mario Buzzi, and that of Renee Forrest is Renee Fruchtbaum. One night after a meeting they succeeded in getting one of the girls in our office to go out with them to a night-club. Buzzi and Fruchtbaum promised this girl a job as a model in New York at seventy-five dollars per week, and ease and plenty the rest of her life, if she would turn against the Columbians. The two Jewish-Gestapo agents were leaving for New York that night by air and would leave an airplane ticket at the airport for her in case she decided to go up there. They left the New York

telephone number of the Anti-Nazi League with her. The next morning at the Columbian offices she told everyone there about her experience of the night before. Ralph Childers and Lanier Waller overheard what she had to say. They put their heads together and decided they would play the role of Judas. They called Buzzi and Fruchtbaum in New York and another airplane ticket was sent down and by the next morning both of them were put up in a suite of rooms in a swank New York hotel, with all of the liquor and women they could want.

MONEY, LIQUOR AND WOMEN

Buzzi threw dollar tips to bell-hops and bus-boys and told Childers and Waller that if they would play their cards right they would soon be doing the same. They were drunk about all the time they were in New York. Wild parties of mixed Whites and Negroes went on every night. The young men were introduced to Herman Hoffman, president of the Anti-Nazi Gestapo; Isadore Lipschutz, treasurer, a Jew-refugee diamond broker from Belgium who at that time was not even a citizen of the United States and could speak only broken and gibberish English and James H. Sheldon, administrative chairman of the Gestapo. Sheldon did at that time, and does today, have a Negress as his private secretary. Buzzi told Waller that he was a member of the Communist Party, and everyone in the Gestapo offices talked in praise of Communism. After a

week or so of this wild life, and after signing many lying affidavits while in drunken condition, Sheldon, Buzzi, Fruchtbaum, Childers and Waller took an airplane for Atlanta.

DAN DUKE THE ARCH JEWISH-GESTAPO STOOGES

The three Jewish-Gestapo agents put up in suites in one hotel, and Childers and Waller put up in a suite in another hotel. On the morning of their arrival the five of them went to the office of Dan Duke. After a hasty conference Duke told two Georgia Bureau of Investigation agents to accompany Waller and Buzzi on a quest to buy some dynamite. He also had a carload of newspaper photographers ready to go along with them. These people left Duke's office in two cars, the photographers following the car of the GBI agents in which were Waller and Buzzi. Waller, in the company of Buzzi, succeeded in buying several sticks of dynamite from some poor, illiterate and ignorant well-diggers, at ten dollars per stick. Waller says they had the money to pay one hundred dollars per stick, or even more, for the dynamite if that had been necessary. But seventy or eighty dollars is a great amount of money to a poor well-digger. Immediately the GBI agents arrest Waller and the well-diggers, and the photographers start banging away, all as planned by Duke, and the Atlanta and New York agents of the Jewish-Gestapo. All of this happened on the morning of December 10, 1946.

That afternoon a great conference was held in the office of Eugene Cook, the Attorney General of Georgia, in which Sheldon spoke and said that Dan Duke had invited his organization to send agents into Georgia for the purpose of investigating the Columbians.

SCREAMING HEADLINES ABOUT DYNAMITE

That afternoon the Atlanta Journal roared forth with a huge headline—**TWO COLUMBIANS BARE AIMS OF TERRORISM**—and a great front-page story told about the conference in Cook's office. In a four-column space on the front-page appeared a photo in which Buzzi, Sheldon, Waller, Childers and others were displaying dynamite which was alleged to have been owned by our organization, when as a matter of fact it had been purchased by Waller at the direction of Dan Duke. Neither I nor any of us had any more to do with that dynamite than the man in the moon, but that huge photo on page one served the propaganda purposes of our enemies, as Dan Duke and his Jewish masters knew so well would be the case. The average person reading that paper received the impression, in no uncertain terms, that we had bought and owned that dynamite, and that our object was to dynamite Negro houses. Our enemies were trying to convict us in the minds of the public before our trials.

WE COUNTER-ATTACK

I was out of Atlanta at the time of this confer-

ence in Cook's office, being in Montgomery at the bedside of my ill mother, but as quickly as I heard of it over the radio, and in a front-page article in one of the Montgomery newspapers, I hurried to Atlanta. On December 12th I swore warrants against Renee Fruchtbaum, alias Renee Forrest; Mario Buzzi, alias James Falco, and Jacob Shapiro, alias Dr. James H. Sheldon. I accused them of having violated sections 26-4901 and 26-4902 of the Georgia Criminal Code; viz., of having illegally acted as detectives and policemen. None of them were citizens of Georgia, and none of them were legally authorized to act as detectives in the State of Georgia. According to the sections of the Criminal Code mentioned above—which were enacted by the Georgia Whiteman's legislature after the Reconstruction tyranny to fight Carpetbagger detective agencies—both of these requirements must be met. Sheldon had boasted in the press that his agents had acted as detectives, and the Anti-Nazi League in a form-letter—a copy of which is in my possession—actually boasted that Sheldon directed the investigation. Fruchtbaum had boasted that she was a "spy" within the Columbian organization. Dan Duke boasted in the press, and later under oath in court, that he invited the Anti-Nazi League to Atlanta to investigate our organization. The hearing on the Sheldon warrant came up on the 14th before Judge Quincy Arnold. Our attorney at the time, J. E. B. Stewart, called Congressman Wood of the

Un-American Activities Committee and he confirmed what we already knew that his committee had listed the Non-Sectarian Anti-Nazi League as a Communist-front organization. We had tremendous evidence on our side. But in spite of all this, and the brave all-day courtroom battle waged by J. E. B. Stewart, the judge dismissed my warrant against Sheldon for lack of evidence! Later the judge told Ed Bridges, an Atlanta reporter and one of my witnesses who attended the conference in Cook's office, "*Ed, old boy, you had me scared for awhile. It looked like I was going to have to bind over Sheldon. I would had to have done so if you had said 'investigator' rather than 'investigating'!*" This same judge dismissed my warrant against Fruchtbaum in January, 1947 on practically identical circumstances. My warrant has never been served on Buzzi. He skipped town before it could be served, but I know one deputy in particular who is still anxious to serve it on him. The mills of the Lord grind slowly but exceeding fine.

WE ARE INDICTED

Armed with the so-called evidence, furnished by Buzzi, Sheldon, Fruchtbaum, Childers and Waller the Solicitor General (Prosecuting Attorney) E. E. Andrews went before the Fulton County grand jury on December 13th and obtained two indictments against me: illegal possession of dynamite and riot. In the riot indictment Andrews used as the State's

chief witness a young man with a lengthy criminal record, whom he had just indicted that very same day for car theft. This young man, Clarence Kight, later stated that the whole case against us was a frame-up. Ira Jett, a loyal and devoted member of our organization, was also indicted for illegal possession of dynamite. Our enemies, undoubtedly, wished with all their hearts that Ira Jett would weaken under such terrific strain and turn State's witness. But, thank God, Ira Jett did not testify to such a lie. I was so busily involved on the 14th in my courtroom battle against Sheldon that I did not make arrangements about my bail. Upon the conclusion of the Sheldon hearing I was imprisoned in the Atlanta Tower.

THE LIGHT BREAKS THROUGH THE DARK CLOUDS

While the grand jury was in session on the 13th Westbrook Pegler was firing away with some thunderous blasts against the Non-Sectarian Anti-Nazi League. His articles appear in the Atlanta Constitution. But Ralph McGill, Jew-stooge editor of that newspaper, held-up these articles during that time and did not publish the first of them until December 17th. McGill simply did not wish the grand jury to learn the truth about this deadly crowd of mongrelizing Jews and Negroes. As soon as I was released from the Tower on bail my friends showed me the first of these powerful articles, which had been published in New York. I viewed that article as the clear light of hope and victory

that always breaks forth through the dark clouds of disappointments and defeats, when men fight for a good and God-sanctioned cause. At long last a prominent and nationally known columnist had taken up the sword of truth, and with it was striking mortal-blows against the enemies of our people and race. Here are excerpts from the article:

New York—A few days ago a startling story broke in the papers under an Atlanta dateline concerning a secret organization called the Columbians, which appears to be anti-Semitic and anti-Negro.

The "break" of the news story was contrived in dramatic fashion, revealing a professional touch. The only ground for the startling allegations was the "confessions" of two young backsliders, 18 and 21.

If this is a sinister and dangerous organization, however, it obviously is petty by comparison with the outfit which arranged the expose.

That organization is the Non-Sectarian Anti-Nazi League of New York. It was organized in 1933 to boycott Hitler's Germany and, by other means, to oppose the rise of Hitlerism. In the years since it has become, by its own boast in the Atlanta case, a secret, private espionage system.

It has no official equal in the agencies of the United States government which even to this day do not include a "secret police" service of this type. . . .

The Non-Sectarian Anti-Nazi League has absolutely no standing as an official agency of any branch of the government nor does it present itself to the public as a secret police or detective agency. It operates in the guise of a group opposed to Hitlerism and similar

methods amounting to moral and political blackmail. In the Atlanta case, nevertheless, its agents boastfully told of their cleverness in worming their way into a private group.

The Non-Sectarian Anti-Nazi League has no more right to employ the methods that it did employ against the Columbians than it has to do the same thing to the Masons, the Knights of Columbus, to any innocent, law-abiding family or business organization. . . .

The President of the League is Herman Hoffman and the Treasurer is Isidore Lipschutz. Lipschutz is a refugee diamond broker from Belgium who appears to be either a rich man in his own right or to have large financial backing.

The day after the news of the League's coup in Atlanta, I telephoned the office of the League in New York to ask information. . . .

After I asked the man with the accent whether Lipschutz were a citizen and he had answered "I couldn't tell you", he asked me, "Are you?"

"Yes", I said. "A native. Are you a citizen?"
"I am an African", he said, "An Abyssinian".

And when I asked his name he answered in gibberish, which may have been his name, at that. An American ear easily might have had trouble with his name, even if he had spelled it out.

Such is the experience of one loyal, native citizen of the United States in an honest approach, without jimmying, wire-tapping or pilfering, to this private espionage system, operating under the financial administration, possibly with the financial support, of Mr. Lipschutz, the Antwerp diamond broker.

E. E. Andrews, the solicitor-general of Atlanta, may feel pleased with the momentary and noisy results of his collaboration with the Non-Sectarian Anti-Nazi League. In that collaboration, however, the State has given official recognition to an organization no less secretive than the Columbians and much more efficient and, therefore more dangerous to the peace, freedom, privacy and dignity of the citizens of Georgia and all the other States.

I AM STRUCK A COWARDLY BLOW AS I SHAKE THE JUDGE'S HAND

During the course of my fight in Atlanta I appeared in court before Judge Edgar Pomeroy on a matter concerning our charter. Mr. Phil Davis of Tulsa, a well-known nationalist and a brilliant lawyer, accompanied me as counsel. Dan Duke appeared representing the State. The judge agreed to grant the request asked of him by Mr. Davis. Duke is a man with an extremely hot temper and was infuriated by this rebuff from the judge. I shook hands with the judge and said: "*Judge Pomeroy, I am glad that men like yourself are still on the bench, for as long as they are I know our Anglo-Saxon freedom is secure*". As quickly as I had uttered these words while my hand was in the hand of the judge, Duke comes rushing up behind me and strikes a heavy fist-blow upon my left-eye. The ring on his finger cut a gash above the eye. He gave me no chance whatever of protecting myself, as he ran up from behind my back, and struck the blow which I had no reason whatever to anticipate.

I was shaking the judge's hand, and I thought I was in a civilized courtroom. We were not, as the newspapers inferred, engaged in an argument; I was unaware that Duke was within hearing of my voice when I spoke to the judge. The judge did not cite Duke for contempt of his court. But it is reasonable to assume, however, that if I or any of my friends had done such a dastardly thing all of us would have been thrown under the jail. I had to swear an assault warrant against Duke. A preliminary hearing was held on this case and Duke asked for a jury. This case was on the calendar once to be heard by a jury, but the chief witness, the judge, was unavailable as he was reported to be ill. This incident—together with many others—proved to me that under the present tyranny of the Jews and their stooges a man has no more legal rights in reality than the power of the organization to which he belongs. I still have the bloody-handkerchief with which I wiped my bloody-face that day, and I shall ever keep it as a priceless memento of the struggle we are waging to put our country back into the hands of real Whitemen, and out of the hands of the tyrannical Duke-type Sealawag, and his Jewish Carpet Bagger masters. Again, the mills of the Lord grind slowly but exceeding fine!

THE JEWISH-GESTAPO AND MY TRIAL

My trial began February 19, 1947. Members of the Jewish-Gestapo were there in full force. Space

does not permit me to go into the details of the trial. But throughout its entire length the solicitor's office was in close collaboration with agents of the Non-Sectarian Anti-Nazi League. They testified against me during the trial. There were in all three indictments against me, a total of seven counts. I was convicted on three counts, and sentenced to serve a year on each count, or a total of three years. In the opening statement the solicitor, entirely overlooking the simple and plain acts involved in the indictment, accused me of being the head of a conspiracy to overthrow the governments of the City of Atlanta, the State of Georgia and the United States. It was clearly a case of being indicted on one set of alleged facts and being tried on another. This is the typical technique of the Jewish-Gestapo in its frantic effort to destroy our American civil liberties. One of the trial jurors also served on the grand jury that indicted me. The Jew-controlled press had prejudiced the jury against me. Any and all kinds of so-called evidence was allowed against me, but members and friends who wished to offer evidence for me were not allowed to do so. I was not even allowed to enter the State-granted charter as evidence of our objectives and ideals. I had the officials of the railroad where I had been employed as character witnesses, but their testimony was not allowed. Neither of the two lawyers I had—W. George Thomas of Atlanta, and Herman Ross of Tennessee—were acquainted with the vicious

trial-tactics of the Jewish-Gestapo. Mr. Ross, a brave fighter for the Whiteman's cause, is a kinsman of President Andrew Jackson, and the same spirit lives in him that lived in Old Hickory, but his straightforward honesty was no equal to the devilish cleverness of the Gestapo. The judge during my trial was Carl Crow of Camilla, Georgia—a judge out of the Atlanta area and a man who, one would think, would not be prejudiced against me—but I challenge anyone to read the record without having the thought driven home to him that the Jewish-Gestapo was well-pleased with his performance. The judge erred over and over again. I was found guilty—as the Jews, their contemptible Scalawags and the mongrelizing Negroes laughed and giggled—and was sentenced to serve on what is commonly called the chain-gang. I told the jury that if I were guilty of having done anything wrong then every Whiteman of the Southland who feels that his Way of Life is threatened with destruction is also guilty with me. Thank God there is a higher authority than the verdict of that courtroom. That authority rests within the sovereign will of the Whitemen and Whitewomen of America, and the day is coming—in spite of all the Carpet-Baggers and Scalawags—when that sovereign will shall give its approval to everything I did in Atlanta in 1946-47. I told a reporter, after hearing the anathema of Judge Crow, that the conviction would only strengthen my de-

termination to do my part in saving the Whiteman's Way of Life. Boyce McTyre, my dear friend who has stood by me in all of my struggles, proudly signed my appeal bond, as a photographer banged away, using his home as the security. The case has been in the courts since that time.

AFFIDAVITS ADMITTING PERJURY

James Akin was among the first three members of the Columbians. He gave his life to the principles for which we fought, and asked nothing in return except the satisfaction of feeling that he was helpful, a little food and a cot in the Columbian offices. I trusted him as a brother. I knew neither Waller nor Childers very well. But I loved James Akin and saw in him one of the most valuable members of the movement. It is difficult to believe but he, too became a backslider. The thought of prison doors closing on him as one pathway, and the alternative of an unlimited amount of money, ease and luxury for the rest of his life, made the decision for him. But in June, 1947, after the trials, his conscience hurt him so badly that he decided to come forward and tell the whole miserable story about the frame-up. He admitted in an affidavit that he perjured during the trials, and stated that he was willing, if necessary, to serve time to right the wrong that he had done. He stated that he was threatened by the solicitor's office with twenty years imprison-

ment if he didn't forsake the Columbians and testify against them. He stated that Dan Duke had told him that if someone would kill the leadership of the Columbians that he would see to it that the murderer would go free. Lanier Waller has also come forward since then and written an affidavit in which he attests to our innocence, and in which he tells about the vicious technique of the Non-Sectarian Anti-Nazi League. An affidavit of Mrs. Maud Rainey, a member of the organization, states that Paul Webb, an assistant solicitor at the time, tried to persuade her to perjure. I have also in my possession other affidavits as evidence that there was—and still is today—a deliberate conspiracy on the part of the Jewish-Gestapo and its stooges to deny me my constitutional rights.

THE EXTRAORDINARY MOTION

Last summer, after the case proper had gone up through the Georgia courts and the conviction had been confirmed, I filed an extraordinary motion based upon the Akin affidavit. By the supreme effort of my lawyers, James Venable and Jackson Barwick of Atlanta, I finally succeeded in having it recognized, but my bond was raised from \$3000 to \$6000. J. L. Shipp of Atlanta, one of my dearest friends, Boyce McTyre, and another dear friend Marshall Adams, finally succeeded in making the bond. Soon thereafter I went to Baltimore and

worked as an architectural draftsman, until the Jews brought such pressure against my employer that I was released. Everywhere I work the Jews cause me this kind of trouble. I could write a book about this phase of my fight.

THE VICIOUSNESS OF THE JEWISH-GESTAPO

The Jewish-Gestapo does not only wish to put behind bars, and exterminate, those who have the courage to oppose it, but it also goes after all those who are friendly with its enemies. Both of my lawyers have been approached by Gestapo efforts to have them drop me as a client. The Jewish-Gestapo tried to send one of my lawyers, James Venable, to prison on a trumped-up charge. He was indicted for attempt to bribe on the basis of testimony by an Assistant Solicitor that he had offered him \$500 to be used as a bribe to get a suspended sentence for one of his clients. This same Assistant Solicitor later resigned and gave to the press his reason for doing so the pressure that Paul Webb, who is now Solicitor General, had exerted against him in the Venable case. The case was *not prossed*. Venable told the press that Webb brought this indictment against him because he had the courage to file the Akin extraordinary motion in my case. This incident is typical of the extent to which the Gestapo will go in its efforts to exterminate not only its open foes, but the friends and even lawyers of its foes. Until it is stamped out and the blasphemy,

the foul hypocrisy, and the treason of its stooges, the traditional rights of the Whiteman in America cannot be secure. It is composed of cowardly bullies who do not dare act openly, but must work forever in an undercover and underground manner, worming their way into our homes, schools, churches, politics and courts. It breeds on the poisonous philosophy of turning Whiteman against Whiteman, and springs from the cess-pools of the mongrelizers.

Civilization is founded on the name and teachings of Jesus Christ. It follows, therefore, that the enemies of civilization are necessarily the enemies of Jesus Christ. The worst enemy of Jesus Christ is the Jew. The Jews sought to kill our Lord (John 7:1). They precipitated His persecution. They demanded His crucifixion. They brought about the persecution, assassination and imprisonment of all the Apostles and many of the other early Christian leaders.

The most un-Christian and uncivilized movement on earth is Communism. It is anti-Christian and is referred to by some as the politics of the anti-Christ.

3. The Jew Leon Trotsky (real name: Bronstein) was the generalissimo of the Red Russian Army which slaughtered over 10 million Christians.

What About Stalin?

Stalin's second wife is his former mistress, the Jewess, R. M. Kaganovitch, daughter of Lazar Kaganovitch, Commissar of Heavy Industries and often spoken of as Stalin's probable successor. There are no less than six Kaganovitches, holding 22 high political offices among them, surrounding Stalin. This Jewish family is probably the most powerful in Russia. Yiddish, incidentally, is the language spoken in Stalin's home as it was in Lenin's.

There has been no change in the extent of Jewish control since the early years of the Communist revolution. Indeed, as recently as 1935 Major Yeats-Brown (*European Jungle*, page 181) states that "in the Central Committee of the Communist Party, consisting of 59 members, 95 percent were Jews—i. e.,

56 members—while the other three members were married to Jewesses: Stalin, La'bo. and Ossinsky."

The *Jewish Chronicle* for January 6, 1933, page 19, says "Over one-third of the Jews in Russia have become officials."

by saying that "Jews in leading government positions are endeavoring to introduce a governmental structure which the majority of their peoples do not desire." Since the government of Poland is now Communistic and a puppet of Stalin, this again reveals Jews in key positions in a Stalinist Red regime. Romania is another of Stalin's puppet states. *The American Hebrew* of August 15, 1947, boasts that the Jews control Romania.

Let us not forget that both Stalin and Molotov, the two most powerful men in Russia, are married to Jewesses.

Every current exposure of Communists in the U. S. reveals a list of Jewish or largely Jewish names. Thus when a group of Reds picketed Churchill in New York City (after Churchill turned against Stalin) and were arrested for their demonstrations, their names as disclosed by the *New York Times* of May 11, 1946, turn out to be 100 percent Jewish: Albert

The five men ousted by the Army from the Aberdeen Proving Ground because of "*irrefutable evidence that they were members of the Communist Party*" (Washington Star, July 19, 1946) were all Jews: Harry Spector, Phil Weiss, Irving Spector, Abraham Kotelchuck and Rheabel Mendelsohn.

Although only 5 percent of the population of the United States is Jewish, 60 percent of the ten State Department aides dismissed for suspected disloyalty (Communists) bear Jewish names: Irving Goldman, Hannah Goldman, Florene Levy, Bernard Nortman, Alexander Lesser and Harold Weisberg. (Washington Times-Herald, September 21, 1947.) The remainder may also have been Jews since many Jews have been concealing their racial identity behind old Gentile names.

As everyone knows the Congressional Committee for the Investigation of Un-American Activities has done some of the most important work in the United States to expose Communist infiltration into our government. When the continuation of this vital Committee came up before Congress, every Jew in Congress voted to discontinue the Committee on Un-American Activities. The record is available for everyone to see in the Congressional Record of May 17, 1946.

Louis Levine, national chairman of the Jewish Council of Russian Relief, recently paid an extended visit to Russia. His observations and boasts speak for themselves. In an article in the November, 1946, issue of *Soviet Russia Today*, Levin (billed as "outstanding leader of American Jewry") wrote: "Special concern for the Jewish people has characterized the Soviet Union since its birth in 1917. A week after tsarism was overthrown, the infant Socialist government, headed by Lenin, abolished national oppression, making it the first country in the world to declare anti-Semitism a crime." (Any criticism of a Jew in Russia is punishable by death.) * * * "Many American Jews did not quite believe that the anti-Semitic scourge of several thousand years could be wiped out within one generation." (Meaning that all critics of Jews were slaughtered immediately.) * * * "Everywhere in Russia, more than in any other country in the world, Jewish lit-

erature, Jewish theatres, Jewish poetry are basic to a full cultural life."

Levine tells how he met famous Jewish surgeons, a Jewish general, and many other high officials of Jewish origin. He said: "It was apparent that the Soviet Jews participate fully and freely on every level of government activity."

The same Levine, speaking in Chicago on the 12th floor at 32 West Randolph street on the night of October 30, 1946, said: "Many of the high ranking government officials in Russia are Jewish." He explained one of the devices by which the true Russian people are kept in the dark concerning the extent of Jewish control over them: "Many of the Jewish officials did not look Jewish but they spoke to me privately in Hebrew or Yiddish."

Major Robert H. Williams, formerly of the American Military Intelligence, says: "The situation described by Levine undoubtedly reveals the real secret behind the Iron Curtain—the power of the highly organized, utterly ruthless Marxist wing of Russian Jewry."

Levine also explains that the synagogues are open and the Jewish people enjoy complete religious freedom.

Levine confesses, "At the outset of the war Jews were among the first evacuated from the western regions threatened by the Hitlerite invaders, and shipped to safety east of the Urals. Two million Jews were thus saved."

Douglas Reed, the eminent British journalist, said in 1938: "The entire press censorship service in Russia is in the hands of Jews."

Henry Jagoda, merciless head of the NKVD (bloodthirsty secret police) is Jewish.

Concluding his article, Levine says: "The Jewish people are unanimous in their love for Stalin. They regard him as the greatest friend of the Jewish people. They attribute to his understanding of national minorities and to his leadership the new exalted status of the Soviet Jews."

Major Williams, formerly of the Military Intelligence, says on page 30 of his book entitled **Closer-Ups-Supplement No. 1**: "I have evidence of the use of the following devices to conceal Jewish strength in Russia:

1. "Influence by Jewish organizations (The Jewish Anti-Fascist Committee, for example, mentioned by Levine, operating with greater influence, no doubt, than the Political Action Committee behind the New Deal).

2. "Promotion to important posts of Russians married to Jews.

3. "Changing of names by Jewish officials.

4. "Placing in high position Jews who 'do not look Jewish.'

5. "The 'hidden director' device whereby one who appears to be only a clerk or petty aide, occupying an inconspicuous office, is the

real director of a bureau or commission (as, for instance, the Soviet Purchasing Commission to the United States at one time during

the war. Kravchenko* does not give any reason for the invention of this device, but he states that it is frequently used in the Soviet Union. Russia uses this device in directing the Communist Party of the U.S.A. Gerhardt Eisler, a German Jew, reportedly has been the invisible director—known to only the top Communists and therefore deceiving all the little Communist tools.)

6. "Placing responsibility on men who were raised Jewish—as in the case of Manuilsky."

* Kravchenko is the name of an ex-Russian official who recently wrote an expose of Communism entitled *I Chose Freedom*.

Atom Bomb Treachery

David E. Lilienthal, the Jew, is head of the Atom Bomb Commission. Concerning the three high members of the Commission, the Los Angeles *Examiner* on January 9, 1947, said: "*David E. Lilienthal, head of the board, is a long-time ardent New Dealer and a member of at least two Communist-dominated organizations (unless he has resigned very recently), the National Lawyers Guild and the Southern Conference of Human Welfare. The FBI and the House Committee on Un-American Activities hold these groups to be potentially subversive, aligned with the world movement to overthrow this government. Associated with Lilienthal on the atomic energy board is Lewis E. Strauss, also a New Dealer, and a member of Kuhn, Loeb & Company, international banking firm. Americans traditionally distrust international bankers, remembering how many of them have figured in world power politics and exploitation. A third member of the atomic energy board, William W. Waymack, editor of the Des Moines Register, reportedly, is listed in the potentially subversive files of the FBI and the House Committee on un-American Activities. Waymack is vice president of the Americans United for World Government, and a member of the pro-Soviet National Committee for Civilian Control of Atomic Energy. He also was a sponsor of a group*

working for 'medical aid to Soviet Russia' and a speaker before the Communist Russian War Relief—as reported in the pro-Communist magazine, Soviet Russia Today.' ”

Riots Must Be Stopped

EXTENSION OF REMARKS

OF

HON. ROBERT E. JONES

OF ALABAMA

IN THE HOUSE OF REPRESENTATIVES

Monday, June 19, 1967

Mr. JONES of Alabama. Mr. Speaker, the distressing reports of violence, riots, and disrespect for the law are flaring again in widely scattered parts of the country. The same groups of agitators, however, appear to be connected with these terrible outbreaks of chaos, confusion, and outright criminal activity.

We have condemned foreign dictators who seek advantage with threats to disrupt peace among nations and subject neighboring peoples to harassment and subjugation. To avoid open warfare, our Nation has properly sought to settle these problems within the framework of international law and justice. On occasion, this Nation finds it necessary to assert authority and enforce the law in terms of power which can be understood by the lawless.

In our own communities, we must not condone that which we condemn abroad. Just as we seek to bring the force of world opinion to bear against aggressors who would flaunt the rule of law among nations, responsible citizens at home must demonstrate beyond any doubt that public order and law will prevail. To do less is to erode the very foundation of our civilization.

Regardless of the participants, there is absolutely no reason for the strife to which so many communities are being subjected. There is no contention by the rioters which could merit the destruction resulting from this lawless activity.

The loss of life, injury, and damage resulting from riots are tragic enough, but it is far worse that the rioters ignore and disavow the most basic principles of our civilization. Clearest among these is that law and order must prevail for the fulfillment of freedom, and that responsibility is the handmaiden of liberty. And when you consider that means exist for lawful protest and redress of grievances, the riots seem even more futile.

When the disorder is ended, the dead are buried, the fires extinguished, and the rubble removed from the streets, the original contention or problem remains. This lawless action builds no playgrounds; provides no job training; alters to no degree our Nation's commitments; enlarges in no way academic freedom; erases not a single word from the law of the land. Moreover, as the damage is counted, those who incited the mobs will

have moved elsewhere to new violence, in many cases.

Thoughtful and responsible citizens must still seek to resolve the problems and contentions through lawful process and hard work.

Within the family of nations it has long been clear that the appeasement of aggressors is a self-defeating road which leads to greater deterioration of law and international order. Within our communities responsible citizens must make clear to the lawless that threats and disorder will not be rewarded by concessions. Appeasement gives sanction to unlawful action, leads to greater demands, and strengthens the hand of lawless elements in the community.

To capitulate to the rioting mobs weakens the very foundations of our system of government by law. It demonstrates to the lawless that violence has a reward. It intimidates the weak and uncommitted. It attracts to future lawlessness those who want to be on the winning side. It creates more problems than it solves in the present or future.

The time to suppress riots and disorders is before they start. This requires a considerable show of solidarity on the part of the responsible elements of each community—a solidarity for law, order, and progress. It must be clear to all that peace will prevail.

When lawless elements do gain control of a community or an area, outbreaks must be brought promptly under control. No civilization can tolerate violence and mass crime.

Both prevention and control of these outbreaks require improved support for police forces—support stronger than embrace of a slogan. As the very guardians of peace within a community the police merit greatly increased moral support as well as improvements in number, financial incentive, and equipment.

Ironically, the moral support for the police seems weakest in many areas which have the most to gain from a stable, orderly community. The abuse to which policemen have been subjected in many areas is appalling. In far too many cases, the policeman, the most convenient symbol of the community in a complex society, has been used as a scapegoat for personal, social, or economic failures. To these malcontents, it is easier to blame their problems on someone else than to engage in constructive activity to better their plight.

Although the destruction of the lawless is appalling, we must remember that a relatively small portion of the total community is engaged in this activity at this time. An even smaller number is involved in the promotion of this discord. For every individual who throws a brick, many thousands in like circumstances do not become involved in this lawless action.

Those who are preaching anarchy and violence, who advocate violation of certain laws, are out of step with the majority of the community and any substantial segment of it. Their appointment to leadership is not from the people but rather from their own hand. It is enhanced by the exposure they receive in framing their appeals in terms which irritate, shock, or upset.

It is hard to believe that they are sincerely interested in the causes they avow. Their very method of operation through violence, division, and destruction so alienates a vast majority of the people as to be counterproductive.

Those who foster mass crime do nothing to eliminate the deplorable conditions of poverty and ignorance to which they link their calls to violence. That even the link is false is indicated by the vast number of the poor and unschooled who are still good citizens.

Because the violence and mob action and threats is more serious than would be indicated by the total of dead and injured and the value of property destroyed, it is imperative that every responsible citizen make his position clear in support of law and order. Failure to do so gives encouragement to the lawless elements.

Respect for the law is the very heart of our civilization and freedoms. This respect must be demonstrated in more than words and slogans. It must be backed up by action which includes a strong personal commitment to respect and obey the laws, proper support for law enforcement agencies, and full acceptance of a citizen's responsibility to cooperate with the police in maintaining peace in the community.

It cannot be stressed too strongly that each individual is the first line of defense against lawlessness and criminal acts.

Other segments of the community—schools, churches, organizations, and governments—have direct obligations in building greater respect for the law. But in the final analysis the individual is the most important factor in preserving law and order.

The support for law and order must be unequivocal. Selective compliance with the law, whether by individual or community, weakens the entire fabric of our civilization because every man's selection for compliance will differ.

Likewise, the total support for law and order is undermined with appeasement of lawless elements. Appeasement abridges the lawful process for change and gives evidence of society's willingness to deviate from full support of law and order. It enhances the position of those who would bring total chaos to our civilization in an effort to have their will prevail.

The end result is that no law survives save the law of the jungle—the will of the strongest or largest group prevails.

Mr. MICHEL. Mr. Speaker, it is time that the U.N. face up to the facts in the Mideast situation. A realistic approach demands that both parties in this issue come face to face in reaching a decision. Intermediaries will only delay a solution. The Israelis and Arabs must reach an agreement which they can "shake" on.

On Thursday, June 15, Mr. Chuck Dancey, editor of the Peoria Journal Star, wrote a fine editorial which illustrates this point very succinctly. Under unanimous consent, Mr. Speaker, I include the editorial at this point in the RECORD:

U.N. PEACEKEEPING: DOES IT HELP OR HURT?

(By C. L. Dancey)

The United Nations has for twenty years carried on magnificent humanitarian works in backward countries that could not have been done by any other instrument.

It was a device for funneling American aid to places that wouldn't take it from America, directly. Its humanitarian function has been very real.

However, as a peace-keeping agency, there is now a very solid question of whether over all it has not done more harm than good—with an excellent chance that it is presently functioning to set the stage for war, again, in the Middle East instead of permit a real settlement.

The political arm of the UN has been political indeed. Its business has not been peace, but an arena for playing cynical international politics.

Thus, the UN largely invented and created

a series of "new nations" that were not "nations" in any meaningful sense of the word, and gave each of them a vote. (Several are smaller than Peoria and its immediate environs, with tribal societies and tribal loyalties rather than national, to boot).

Then, to curry their favor, the UN, it embarked not on peace but a "war of aggression" with UN troops in the Congo to impose a political solution there that fit the prejudices of the other Africa.

Meanwhile, in the Middle East stepped in to rescue the Arab side from any necessity to negotiate with Israel to reach any settlement in which responsibility.

This constant UN intervention is not possible for Nasser and company for 20 years in the attitude of invective involved in claims that did not exist, in refusing to negotiate or accept any relation to Israel, and "state of permanent war" with Israel.

er aims serving the Soviet Union and its subservient organization in the United States.

U.N. Intervention Red Objective

Red "Educators" Concentrate In South— Georgia Negro Colleges Main Target

TARGET SPELMAN COLLEGE

Edwin H. Cerney, communist "art educator," who was dismissed from Stockton College, California, in 1950 for refusing to sign the loyalty oath, is now teaching at Spelman College, Georgia. Cerney, for more than two decades an active foreign agent, is one of the many Reds who have been sent to the South to sow the seeds of Leninism and rebellion amongst students. He has been identified as extremely active in the California Bay Area from 1950 to 1958, at which time he departed, as directed, for Atlanta, Georgia, with his wife, Isobel Cerney, an international communist emissary. "Red Artist" Cerney, in addition to having been identified as a communist cadre, has been associated with more than two score communist-front organizations.

Accompanying Cerney and residing on the campus is his wife, Isobel Cerney. She has been and is by far the most active agent of the two. She has, over the years, traveled as a communist international emissary throughout the world.

She perjured herself in 1948 when she filed to run for Congress in California when she swore she was not a communist. Her principal activities have been and are today within the varied "peace organizations" such as Women's League for Peace and Freedom (communist front), Sane Nuclear Testing, as well as the "Negro liberation" organizations. She has now, as in the past, together with her husband, become associated with the various Quaker committees. She and her associates at Spelman are active in the varied sit-ins, picketing, marching and demonstrating conducted by the "Student Non-Violent Coordinating Committees."

Professor of "psychology" Harry C. Steinmetz, who was dismissed from San Diego State College, California, in February, 1954, for his Red activities, is now teaching "Soviet" psychology at Spelman. He appeared before the House Committee on Un-American Activities in 1956, and resorted to the Fifth Amendment when questioned as to his communist party membership. Governor Brown of California, who was at that time the Attorney General, vehemently stated that "teachers who stand on their constitutional rights before witch hunting committees" could not be fired.

Steinmetz, a many-times identified communist, is carrying on his Red-directed tactics at Spelman College very much in the same manner as he has for more than three decades. His activities parallel those of the Cerneys.

Two other "educators," who ably work with the Cerneys and Steinmetz at Spelman College, are Professors

Zynn and Foster. Both have been associated with left-wing causes and outright communist front organizations.

TARGET MOREHOUSE COLLEGE

Professor G. Murray Branch is, unquestionably, the most vociferous left educator at Morehouse College and in the entire Georgia Negro College System. This "red fronter" has over the years been associated with more than 34 different commieline ventures, many of which were outright Red fronts. The following are a few of his documented activities: American Committee for the Protection of Foreign Born, Committee for the Appeal for Amnesty for Communists Convicted Under the Smith Act, Committee to Secure Justice for Morton Sobell, Brief Amici Curiae for the Communist Party, International Workers Order, National Committee to Repeal the McCarran Act, National Council for Arts, Sciences and Professions, Southern Conference Educational Fund, Southern Negro Youth Congress.

A close red-fronter at Moorehouse College, to Prof. Branch, is Benjamin E. Mays, who has been closely aligned with more than 32 activities of the left.

Other "educators" who rally around Branch and Mays are Brailaford R. Brazeal, John Hope and Rev. Samuel W. Williams.

TARGET CLARK COLLEGE

The left-wing powerhouse at Clark College is James P. Brawley, active in the Methodist Federation for Social Action, and the Southern Conference Educational Fund.

TARGET ATLANTA UNIVERSITY

Professor Rufus E. Clement has a long and continuous background of outright communist front activities, principally: American Committee for the Protection of Foreign Born, American Council on Soviet Relations, Congress on Civil Rights, Southern Negro Youth Congress, Southern Conference Educational Fund, National Council of the Arts, Sciences and Professions.

Independent Socialist, Lonnie Cross, has widespread influence amongst the student body in his varied left activities.

Working together along the left line at this college are Frank W. Clelland and Charles B. Gopher, having been active in such organizations as the National Federation of Constitutional Liberties, Win the Peace Conference, Southern Conference Educational Fund.

Editorial on Civil Rights

Most of the American press has backed the recent demonstrative actions in our Nation for the "civil rights and liberation of the Negro people." The theory, obviously, is that there should be "civil rights for the Negro, but not necessarily for the white citizens. For the "civil rights" for the Negro, is to associate with anyone he pleases, in schools, housing, etc. But the white man's "civil rights" are more limited: he is not to be allowed to decide where he shall live, eat and where his children shall go to school. In short, it is the theory of sacrificing the white citizens on the altar of Negro "rights." This whole theory is of communist origin.

Negro Progress Rapid

What is the true status of our Negro citizenry? They have made more progress up the economic ladder in the last 100 years than any other race—white, yellow or red—ever made in 1,000 years of history. From a condition of absolute slavery 100 years ago, the Negro citizen has risen to a point where he now fares better than many Europeans—better paid, better housed and better educated. From slavery and ignorance to an economic status superior to the average Frenchman, the average Italian, and the average citizen of West Germany.

Economic Advances

Today the millions of Negro citizens have a total yearly income of approximately \$25 billion. Statistics of 1958 reveal that the American Negro citizen who worked a full year earned a median income of \$3,308 (it is much more today) meaning that half the Negro workers received more than this and half received less. That is more than the \$2,234 that the average worker in Great Britain received, and more than four times the estimated \$800 that the average worker in the Soviet Union received. Twenty-four years ago the median income for the American Negro was \$639, less than one-fourth what he receives today.

Demonstrative, mass - pressure communist tactics were not responsible for this progress. It was the normal evolutionary process that is derived from our God-given free enterprise system, that rewards through initiative, ingenuity and desire to progress. The Negro citizen has done exceedingly well, and will continue; unless they become involved and engulfed by the revolutionary tactic as employed by Martin Luther King, Jr., and his communist associates. His tactic can lead to the destruction of our free enterprise and with it both the status world-wide of both Negro and White.

BROWN RECALL GAINS SUPPORT

The recall of Governor Brown and Tom Braden was suggested in the last issue of "Heads Up" as a means of ridding the State Administration of a leadership that has flagrantly disregarded the mandate of the citizenry; to scrap the collectivist-socialist type of "progressive" education. The Governor has become an instrumentality of the **minority** organization, the strong, left-wing, communist generated California Democratic Councils.

He has also established an unchallengeable record of appeasing, collaborating and capitulating to communist objectives as set forth by the California Democratic Councils; and continues to have association with identified communists.

He recently condoned and encouraged the communist tactic of the sit-down demonstration by members of the Committee on Racial Equality, a communist instrumentality. The sit-down in Sacramento was a public nuisance and in violation of the trespassing code. Brown's approval of this Red tactic can set a precedent for similar Red activities that can result in provocation to violence.

"Heads Up" is grateful for the scores of letters from the many citizens who want to start circulating recall petitions at once.

The Ad Hoc Committee will, in the next issue of "Heads Up," call for a conference of all Californians interested in "Good American" Brown's recall. At that time the Ad Hoc Committee will be replaced by a duly elected permanent committee; and the recall movement will be put into gear.

The Governor and the Chairman of the Board of Education can and must be recalled. Citizens interested are urged to continue sending letters to "Heads Up" expressing their willingness to participate.

Johnson in the 1968 presidential election "unless he changes his conduct" of the war in Vietnam.

"We will go all out to take a stand in voting for someone who is against the war in Vietnam," he said.

ATLANTA—Riot-torn cities of the North now face a new threat of Negro disruption.

The Rev. Dr. Martin Luther King, Jr., is organizing what he calls "civil disobedience on a massive scale." Here are some of the things he talks about:

- A march on Washington by thousands of unemployed Negroes who would camp out in the capital city, somewhat like the "bonus marchers" of 1932.

- A "hungry people's sit-in" at the Department of Labor in Washington.

- Sit-ins of unemployed to block gates of factories in many cities.

- School boycotts on a weekly basis.

The idea, as Dr. King put it, is "forcefully to cripple the operations of an oppressive society." He said:

"To dislocate the functioning of a city without destroying it can be more effective than a riot because it can be longer-lasting, costly to the society but not wantonly destructive.

"Moreover, it is more difficult for Government to quell it by superior force."

Dr. King revealed his latest plan on August 15 at a convention of the Southern Christian Leadership Conference (SCLC) which he heads. His listeners, mostly Negroes, cheered him.

It was the most militant speech yet by the Negro minister who in the past has preached nonviolence, and has worked mostly in the South. Announcing his new tactics in the North, he said:

"Taking into account that rage is a powerful fact of life in the ghetto, the mechanical application of tactics of non-violent marches and meetings which could work among Southern Negroes becomes unsound."

Martin Luther King's Record

Angered House Leaders, Subcommittee Plan To Counter King Demonstrations

By Throwing Spotlight on Aspects of His Life and Associates

WASHINGTON, Aug. 21—Powerful leaders in Congress are rolling up their big guns for their coming confrontation with Dr. Martin Luther King.

Their Big Bertha—the contents of the FBI's file on King — has been examined and readied for firing by a House Appropriations subcommittee headed by Representative John J. Rooney, D-N.Y., a strong civil rights advocate.

Subcommittee members are now discussing with House leaders how and when this untold part of the intriguing King story should be released to the American people. This story includes details of those directing and influencing his activities.

These legislators are taking the position that King's public declaration of war on Congress leaves members no other course than to throw the spotlight on some unpublicized aspects of the militant civil rights leader's life — known only to a few high officials and a handful of FBI agents.

The subcommittee members have told the House leaders, who are King's main targets, that the FBI has unimpeachable evidence including photographs showing that King is now listening to a man who is clearly more interested in destroying the U. S. than in the plight of either the Negro or the war-weary people of Vietnam.

According to these legislators, the FBI has carefully docu-

nent Investigating Subcommittee plans a full-scale probe of recent race riots, reports that the inquiry will go into King's activities. Several ex-FBI agents, familiar with the background of King and also of the officials of SNCC, will be employed by the committee.

With these and other bombshells fused to ignite, congressional leaders are privately predicting the "Second Coming" of King, as his Washington disobedience campaign is being called, could be a nasty, violent affair.

The legislators also believe the fireworks could explode a lot of myths about King.

THE VIETNAM FRONT—Communist leaders in Hanoi are taking an interesting view of next month's presidential elections in South Vietnam.

While Johnson administration officials here are contending that the elections should help solve or ease South Vietnam's political crisis, the Communists take just the opposite view.

Their analysis, beginning to appear in official Communist publications, takes the line that the September 3 elections will actually deepen the political crisis in Saigon.

"These elections," a recent article in Hanoi's daily Nhan Dan states, "will further exasperate internal contradictions plaguing the ranks of U. S. officials in South Vietnam and will

mented that this adviser of King has been one of the Communist Party's biggest money raisers in this country.

The confidential FBI file, they report, cites instances of material this adviser has prepared for King's vicious attacks on Congress and the U. S. in general. The adviser is credited with drafting King's statements describing Congress as "wild with racism" and describing the U. S. as "the greatest purveyor of violence in the world today."

KING'S OBJECTIVES — As reported in this column on August 4, eleven days before King revealed his new strategy in his headline-making attack on Congress in Atlanta, the Nobel Prize winner is planning to lead massive demonstrations and "sit ins" here this fall.

The attacks against Congress are part of King's over-all campaign to establish a political "third force" by 1968 composed of militant civil rights, peace, student, and labor groups.

Significantly, the Rev. James Bevel, another King lieutenant organizing his civil disobedience campaign for Washington, is described in the FBI file as King's link with the Student Non-violent Coordinating Committee (SNCC). The officials of this militant group are urging Negroes to follow the path of violent revolution in the U. S.

King, who preaches non-violence, continues to confer with these SNCC officials whenever Bevel sets up the meetings, according to the FBI files. It also quotes King as telling a group of left-wing students, "We don't need to talk mean, we need to act mean."

Aides of Senator John McClellan, D-Ark., whose Perma-

force Washington to look for a way out."

As the Communists see it, the elections will widen the differences between U. S. military and political objectives in South Vietnam.

The Nhan Dan article, being carefully studied by U. S. intelligence, puts it this way:

"The elections will highlight the inconsistent attitude of the Americans in Saigon, where the military group of General William Westmoreland supports the Thieu-Ky military and Ambassador Bunker and his group oppose them because of the need for a political settlement."

According to U. S. intelligence sources, the Nhan Dan article is significant because it spells out Hanoi's new belief that the U. S. will use the elections to find a way out of Vietnam.

In the past, Hanoi's official line was that the U. S. planned to step up the war after the elections, including a possible landing north of the demilitarized zone. This possibly now is being played down.

VIETNAM FALLOUT — More than 100 suspected Communist agents, including a number on the government's payroll, have been arrested in Saigon within the past six weeks by South Vietnamese security officials. Among those picked up were a Vietnamese army officer who headed the biggest government ordnance depot in the country. The arrested Vietnamese officer confessed he was planning to blow up the depot before the September elections. He also revealed that his communications with Hanoi were sent via Paris. The South Vietnam security officials were assisted in tracking

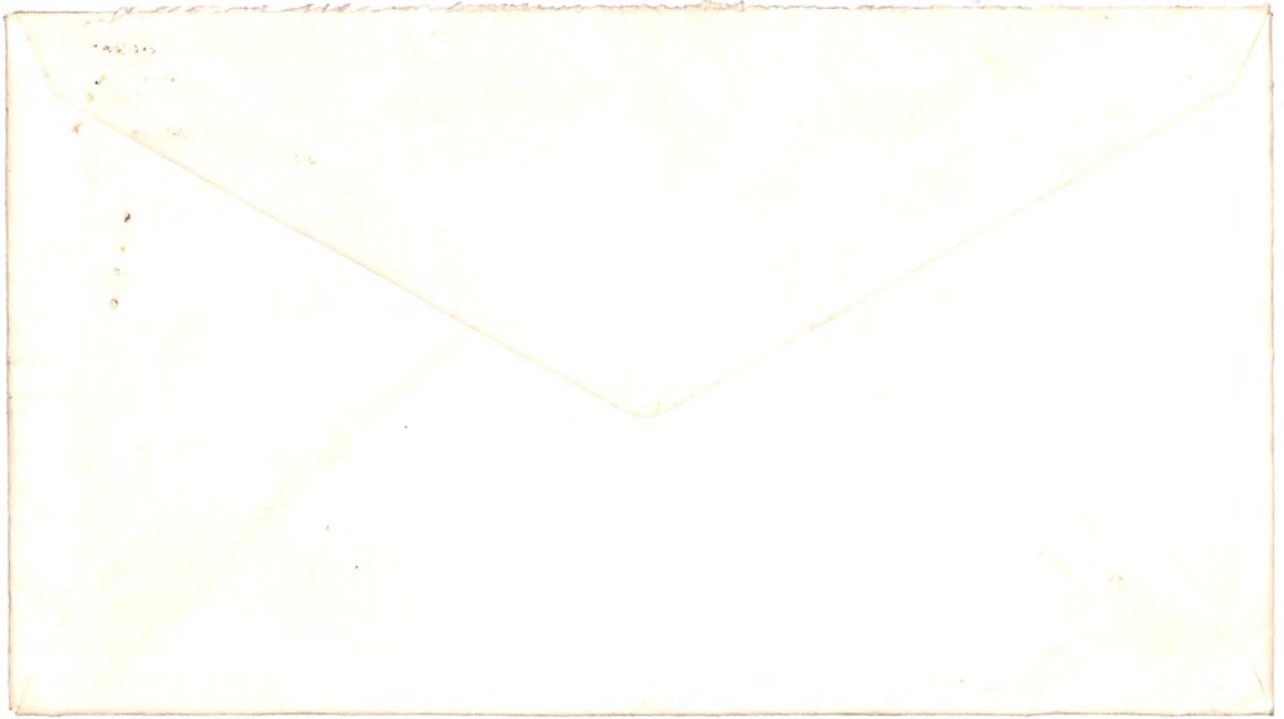

\$20,000 FOR JAILING

SAN ANTONIO, Tex., Jan. 31 (P)—Anastacio Vargas, 74, convicted, sentenced to death and later pardoned for a murder he didn't commit, received a \$20,000 judgment in a false imprisonment suit against the state.

Vargas received the death sentence in a 1926 trial for the slaying in 1925 of a woman. The sentence was later commuted to life and in 1929 he was pardoned. A later investigation showed he was innocent.

Vargas won a \$26,500 judgment in 1958, but a higher court set it aside. He refiled his suit after the state legislature passed a law permitting persons to sue the state for false imprisonment.

Judge Robert Murray made the \$20,000 award. Vargas had sought \$25,000, the maximum permitted under the state law.
